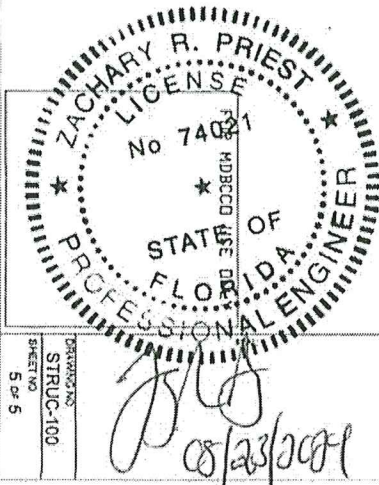
CR209 STEEL HAT CHANNEL
