

#### **Description:**

#### Substrates and Sto products approved with the system

- 18 ga., 6" x 1 5/8" steel studs at 16" o.c.
- 1.2 5/8" National Gypsum eXP ASTM C 1177 compliant sheathing fastened to framing with No. 8 wafer head self drill screws at 8" o.c. along studs and perimeter
- Sto Primer/Adhesive-B polymer modified portland cement base coat used to embed reinforcing mesh on sheathing
- Sto Armor Mat XX, 20 oz./yd<sup>2</sup> glass fiber reinforcing embedded in Sto Primer/Adhesive-B on sheathing
- StoGuard with Sto Gold Coat air and moisture barrier coating applied to dry Sto Primer/Adhesive-B
- Sto DrainScreen, random filament drainage mat with nonwoven polyester facer (optional component)
- 1.7 Sto Powerwall Stucco: pre-bagged portland cement stucco mixed with sand and water in the field
- Sto textured finishes / StoCast finishes:

#### **Application**

- Sto Primer/Adhesive-B base coat is mixed in accordance with written instructions on the bag and used to fully embed Sto Armor Mat XX reinforcing mesh on the sheathing surface. Base coat is allowed to dry overnight.
- Sto Guard with Sto Gold Coat is applied to the dry base coat in accordance with Sto written instructions.
- One layer of Type D, No. 15 asphalt saturated kraft paper is placed over dry Sto Gold Coat as a slip-sheet.
- Fasten 2.5 lb/yd<sup>2</sup> self-furring, galvanized expanded metal lath to the framing at 7" o.c. using No. 8 x 1 1/2" wafer head self drill screws in accordance with ASTM C 1063.
- Where specified, install optional Sto DrainScreen drainage mat using sufficient corrosion resistant fasteners to hold in-place. Final attachment by lath fasteners.
- Apply Sto Powerwall stucco as scratch and brown coat. Mix stucco with approximately 200 lbs of clean sand and potable water in accordance with instructions printed on bag. Moist cure brown coat minimum 48 hours, then allow to dry, before applying
- Apply Sto Textured Finishes / StoCast Finishes in accordance with manufacturer's published product instructions.

#### **General Notes:**

- This system has been designed in accordance with the Florida Building Code, 2020 and 2023 Edition.
- This system has been tested in accordance with Florida Building Code TAS 201, TAS 202, and TAS 203.
- This system shall be applied by a licensed plastering contractor.
- The Engineer or Architect of Record for each project using this system shall design the framing and sheathing as required by governing codes and this document.
- 5. All study used with this system shall be completely sheathed at the interior flange or bridged at a maximum every 5 ft. of study length or as specified by stud manufacturer.
- All steel studs shall be structural with 1 5/8" minimum flange width and a minimum yield strength of 33000 psi.
