#### APPROVED APPLICATIONS

Tile Off Ridge – Weather Vent® **Trade Name:** 

**System Type A:** Mechanical attachment of static roof vent under clay or concrete roofing tiles.

Slot: Cut a 2 ½" wide slot opening in the roof sheathing. Locate the top of the opening 18" from

the ridge. Refer to 'Detail Drawings' for length of slot cutout.

**Installation:** Apply a 1/8" thick bead of an approved ASTM D 4586 Type I roof cement around the

> entire perimeter of the flange. Position the vent over the slot opening. Line the vent with the last course of roof tiles. Fasten the vent with corrosion resistant #10-14 x 1 ½" HWH wood screws and ½" O.D. sealing washers spaced at 8" o.c. on all four sides of the vent flange with a maximim spacing of 1" from the outer edge of the flange and 1 ½" from each

corner.

Seal the vent flange to the underlayment with a 1/8" thick bed of an approved ASTM D

4586 Type I roof cement, as well as convering each fastener head.

Install roofing tiles around the vent in accordance to the roofing tiles' current approved Notice of Acceptance. Install the vent's external baffle on top of the roof tile and fasten to each side of the vent with four (4) corrosion resistant #6-14 x 3/4" pan head screws placed in a 1 ½" square pattern centered in the over lap. Prior to securing the baffle, place a ½" wide

bead of an approved roofing sealant on all contact areas.

Ventilation **Calculations:**  See manufacturer's published literature for net free area.

#### **GENERAL LIMITATIONS:**

- 1. Refer to applicable building code for required ventilation.
- 2. The installation shall be applied in compliance with the manufacturer's current published application instructions and the requirements set forth in the applicable building code.
- Tile Off Ridge Weather Vent® is approved to be installed with high, medium, or low profile clay and concrete 3. roof tiles only, with a maximum tile height of 3 1/2".
- 4. Tile Off Ridge – Weather Vent® shall not be installed on roof mean heights greater than 33 ft.
- All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and 4. Rule 61G20-3 of the Florida Administrative Code.
- All approved products listed herein shall be labeled and shall bear the imprint or identifiable marking of the 5. manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.






2 Braces on 8' vents
