	Panels shall be installed along the rib with SNAP CLAD Clips secured with #10 pancak head screws (2 per clip); the screws shall be of sufficient length to penetrate through th sheathing a minimum of $^{3}/_{16}$ ". - **3.** Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
- 6. Panels may be shop or jobsite roll formed with machine model #('s) <u>8500918, 1950720 and 070602</u> from PAC Contractors Association.
