Metal Panels and Accessories:	Install the "PAC-150 1.5 Aluminum Panel" including flashing penetrations, valleys, end laps and accessories in compliance "PAC Contractors Association's" current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.				
	Panels shall be secured along the male rib with approved clips (PAC-150 Fixed Clip or PAC-150 Sliding Clip) and two corrosion resistant #10 x 1 $\frac{1}{2}$ " pancake head screws of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ ". When using the PAC-150 Sliding Clip, screws must be installed in the outer holes of the base. The panel clips were placed at a spacing listed in Table A below. The female rib of panel is installed over the male rib of panel. Panels are seamed as listed below in Table A .


LIMITATIONS

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
