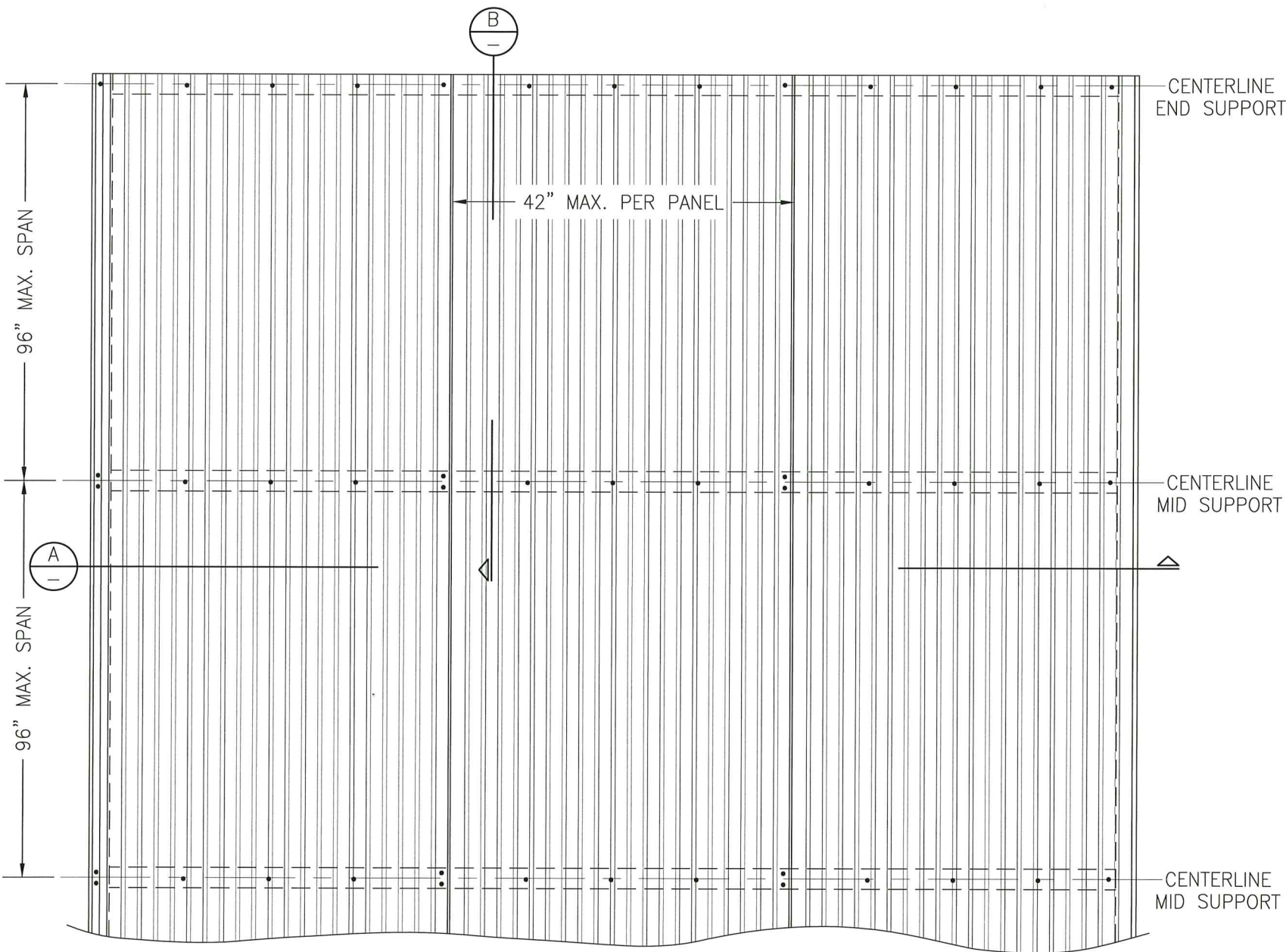
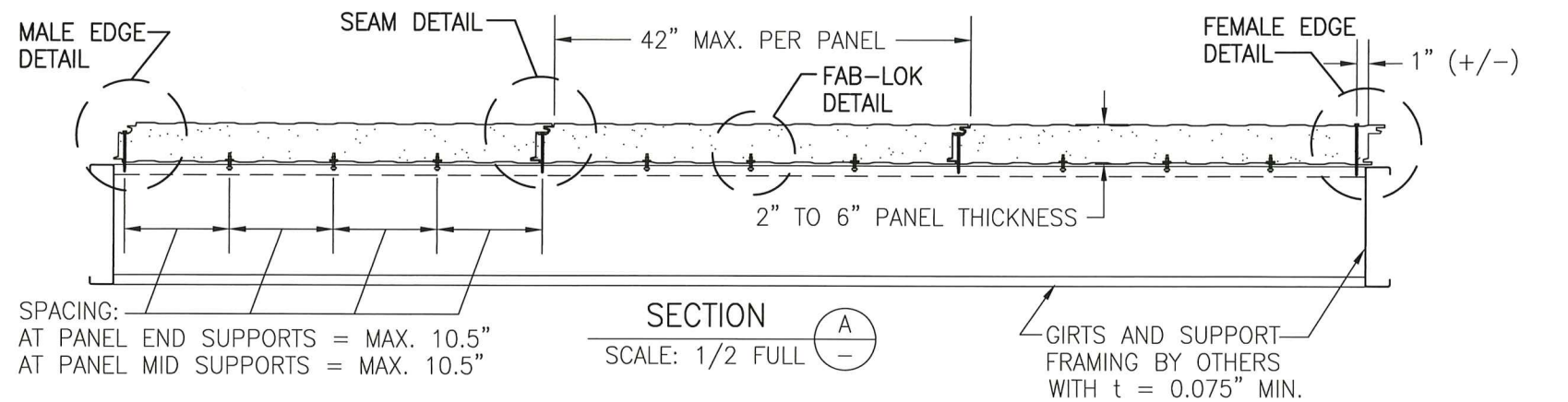

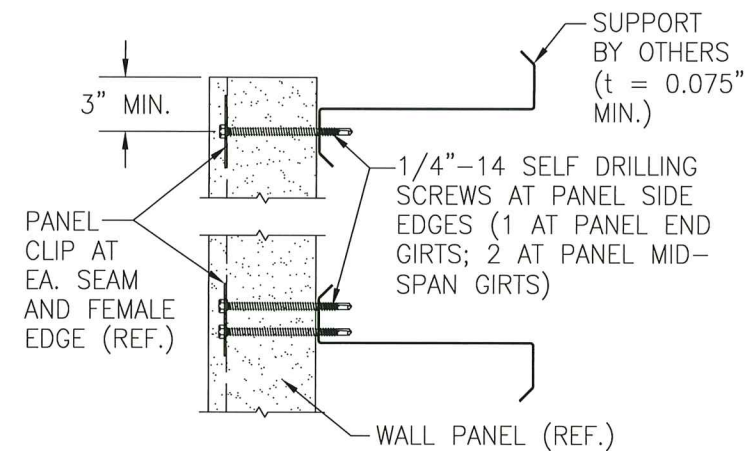


TYPICAL EXTERIOR WALL ELEVATION

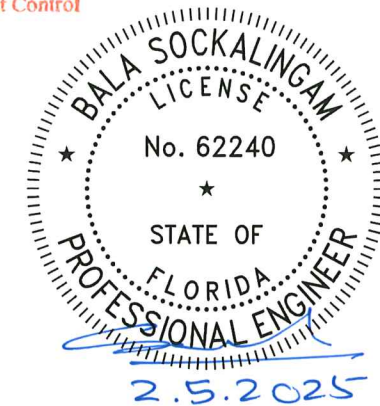

2. ALL WALL PANELS ARE MAX 42" WIDE, CONSIST OF EXTERIOR 26 GA. ($t = 0.019"$ MIN.) AND INTERIOR 26 GA. ($t = 0.019"$ MIN) G-90 CLAD STEEL SKINS ($F_y = \text{MIN. } 44.5 \text{ KSI TESTED}$) COATED WITH AN EMBOSSED & PAINTED OR TUFF (STUCCO-LIKE) FINISH & ARE FOAM FILLED WITH FOAMED-IN-PLACE NON-CFC 2.0 LB/CU. FT. DENSITY POLYURETHANE.
3. THE WALL PANELS SHALL BE INSTALLED OVER WALL STRUCTURE AS SPECIFIED ON THESE DRAWINGS.
