System:	Snap-Clad 0.032" (min.) x 12" thru 18" Wide Aluminum Panel
Deck Type:	Steel, Insulated
<b>Deck Description:</b>	Metal roof deck 22 MSG, G60 coated steel, Minimum 33ksi.
Slope Range:	2": 12" or greater
Maximum Uplift Pressure:	See Table A Below
Deck Attachment:	Minimum 22 gage steel deck shall be secured 6" o.c. to structural supports spaced a maximum of 5 ft o.c. with one (1) $\#12 \times 2$ " Hex Washer Head self drilling screws fastened at the bottom of each flute (6" o.c.). Deck sidelaps shall be fastened 6" o.c. with $\#12 \times 2$ " Hex Head self-drilling screws.
Insulation:	Minimum <sup>3</sup> / <sub>4</sub> " thick and Maximum 4" thick of an approved rigid board insulation with current NOA having a minimum 20psi compressive strength fastened with approved #14 pancake head screws long enough to penetrate the steel deck through 3" diameter insulation plates. Fastening density shall be in compliance with applicable Building Code and Roofing Application Standard RAS 117.
Coverboard:	A single layer of <sup>1</sup> / <sub>2</sub> " DensDeck Roof Board was applied over the insulation fastened with approved #14 pancake head screws long enough to penetrate the steel deck through 3" diameter insulation plates.
Underlayment:	Quick-Stick HT self adhering underlayment or, any approved Underlayment having a current NOA.
Fire Barrier:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with the current published installation instructions and details in PAC Contractors Association's Roofing Installation Manual.
Metal Panels and Accessories:	Install the "Snap-Clad 0.032" x 12" - 18" Wide Aluminum Panel" panels including flashing penetrations, valleys, end laps and accessories in compliance PAC Contractors Association's current, published installation instructions and in compliance with the minimum requirements detailed in Roofing Application Standard RAS 133.
	Panels shall be installed along the rib with SNAP CLAD Clips secured with #14 pan head screws (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the deck a minimum of $\frac{1}{2}$ ". The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance listed below in <b>Table A</b> .


# LIMITATIONS

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
- 6. Panels may be shop or jobsite roll formed with machine model #('s) <u>ENGL-061203</u> from PAC Contractors Association.




1.75" HIGH X 12" THRU 18" WIDE SNAP-CLAD PANEL
