Deck Type 1: Wood, Non-Insulated

Deck Description: 19/32" Plywood, APA rated sheathing, 40/20, Exposure 1, PS1, CDX, 5-ply plywood or wood

plank secured with #8 wood screws spaced 6" o.c. at supports maximum 24" o.c. spacing and

blocking with a maximum 48" o.c. spacing.

System F(1): Membrane self-adhered direct to deck.

Membrane: VShield™ SureTack (PSU 3.0),, self-adhered membrane applied directly to plywood deck.

(See Fastening below for back nailing)

Fastening: Membrane shall be back nailed using 12 ga. annular ring shank nails with 3/8" diameter heads

through 32 ga., 1-5/8" diameter tin caps, 12-in. o.c. within the self-adhering side lap.

Surfacing: Shall be acceptable for use in approved asphaltic shingles, wood shakes, & shingles, quarry

slate, simulated slate roof assemblies, and metal roof applications. Must Comply with

applicable Roofing Application Standdards and Building Codes.

Uplift Design Pressure: -187.5 psf.*

* Underlayment Uplift Design Pressure rating above is included for additional analysis of the underlayment assembly only by the Authority Having Jurisdiction. This value does not include the roof system. Refer to roof system NOA for maximum design pressure of the final roof assembly.

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code.
- 3. VShield™ SureTack (PSU 3.0), shall be applied to a smooth, clean and dry surface with plywood deck free of irregularities. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
- 4. VShield™ SureTack (PSU 3.0), underlayment shall not be hot mopped, refer to manufacturer's published literature for product compatibility.
- 5. VShieldTM SureTack (**PSU 3.0**), underlayment shall not be applied over an existing roof membrane as a recover system.
- 6. MAX EXPOSURE TIME: VShieldTM SureTack (PSU 3.0), underlayment shall not be left expose and shall be covered within designated time; max 180 days exposure.
- 7. VShieldTM SureTack (PSU 3.0), is a component used in roof system assemblies. Roof system assemblies are approved under a specific Notice of Acceptance. Refer to Prepared Roofing system Product Control Notice of Acceptance for listed approval of this product with specific prepared roofing products.
- 8. VShieldTM SureTack (**PSU 3.0**), may be used with any approved roof covering Notice of Acceptance listing VShieldTM SureTack (**PSU 3.0**), as a component part of an assembly in the Notice of Acceptance. If VShieldTM SureTack (**PSU 3.0**), is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- 9. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule **61G20-3** of the Florida Administrative Code.
