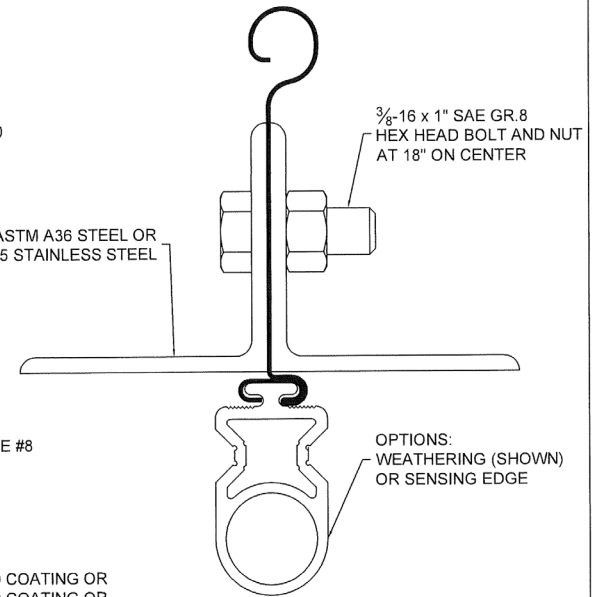


② GUIDE ASSEMBLY DETAIL
