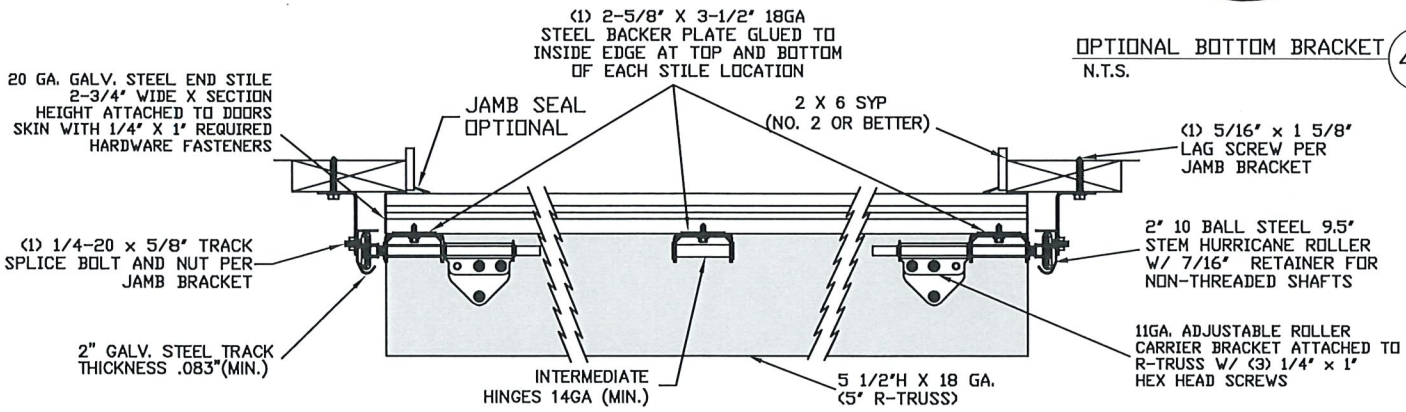
SECTION A-A (SIDE VIEW)

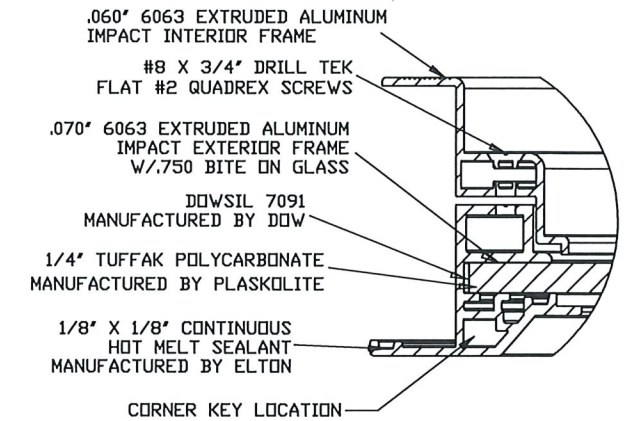
SHORT PANEL IMPACT GLAZING FASTENER DETAIL

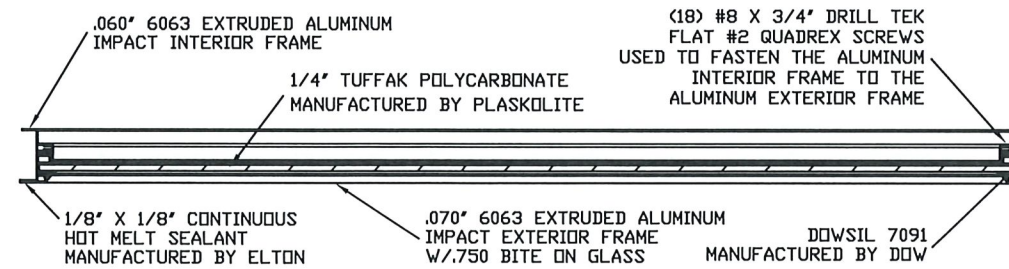
LONG PANEL IMPACT GLAZING FASTENER DETAIL

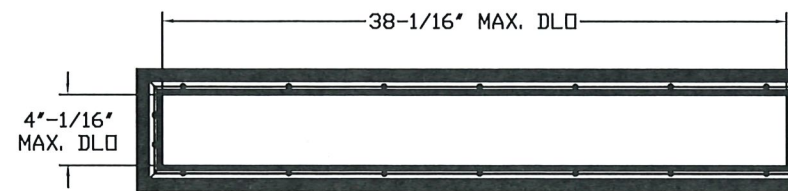
SECTION B-B IMPACT WINDOW DETAIL
