Deck Description:	New Construction ¹⁵ / ₃₂ " or greater plywood or wood plank.

Maximum Uplift Pressure:	See Table A below

Deck Attachment:	In accordance with applicable building code, but in no case it shall be less than 8d coated ring shank nails spaced 6" o.c. and #10 x 1-5/8" flat head deck screws spaced 12" o.c. into the joists. In re-roofing, where deck is less than ¹⁹ / ₃₂ " thick (minimum ¹⁵ / ₃₂ ") the above attachment method must be in addition to existing attachment.
Coverboard:	Minimum ½" thick of DensDeck fastened with approved fasteners and plates. Fastening density shall be in compliance with applicable Building Code and Roofing Application Standard RAS 117.
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1¼" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any Miami-Dade County Product Control Approved underlayment having a current NOA.
Fire Barrier Board:	Any approved fire barrier having a current NOA. Refer to a current fire directory listing for fire ratings of this roofing system assembly as well as the location of the fire barrier within the assembly. See Limitation # 1.
Valleys:	Valley construction shall be in compliance with Roofing Application Standard RAS 133 and with the Garland Company's current published installation instructions.



Metal Panels and Accessories:

Install the "R-Mer Shield (min. 0.040" thick 16 ³/₄" wide aluminum) Roofing Panels" and accessories in compliance with The Garland Company's current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

Install the Hat Channel (18-gauge) fastened using 1/4" x 3" self-drilling pancake head screws 8" on center on both sides of the flange. The channels shall be spaced at a maximum on center spacing listed below in Table A

Panels shall be installed with approved "R-Mer Shield Clips (Base Clip)" located at each panel rib side lap spaced at a maximum distance listed in Table A below, parallel to the roof slope. Each clip shall be fastened with three 1/4" screws of sufficient length for minimum 1/2" penetration through the structural deck.

Top rails are installed along the entire length of the panel seams. Before installing the Seam Cap, apply two rows of a "Miami Dade Approved Sealant" along the top of the top rails. Install the Seam Cap over the top rail and secure in place with a seamer.

Insulation:	Minimum ³ / ₄ " to maximum 4.0" thick of a Miami-Dade approved polyiso insulation with current NOA having a minimum 20psi compressive strength fastened with approved fasteners and plates. Fastening density shall be in compliance with applicable Building Code and Roofing Application Standard RAS 117.
Coverboard:	Minimum ¹ / ₂ " thick of DensDeck fastened with approved fasteners and plates. Fastening density shall be in compliance with applicable Building Code and Roofing Application Standard RAS 117.
Underlayment:	Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 ¹ / ₄ " annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any Miami-Dade County Product Control Approved underlayment having a current NOA.

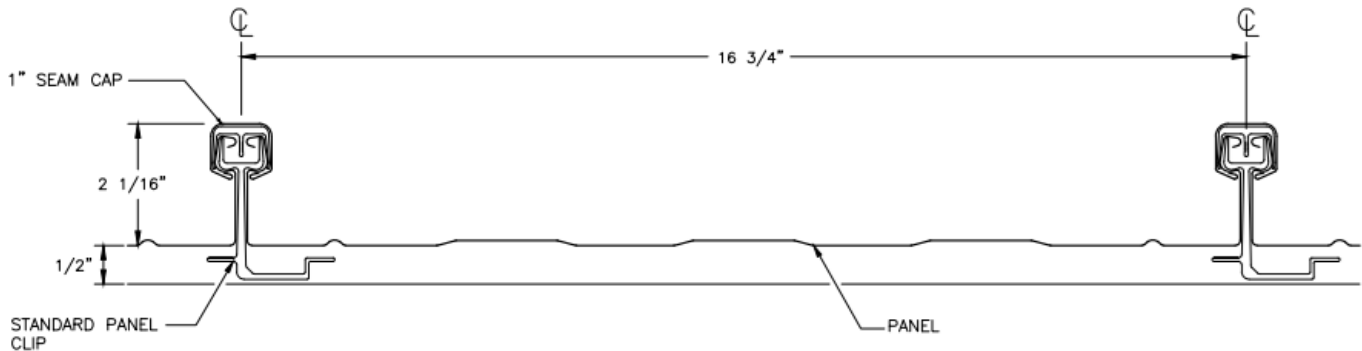
SYSTEM LIMITATIONS

2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.

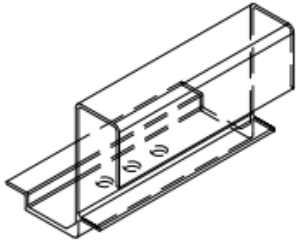

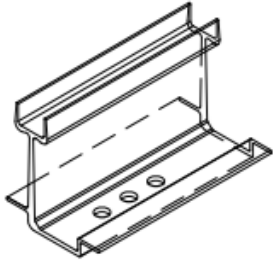

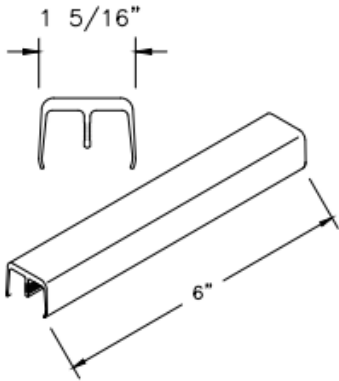

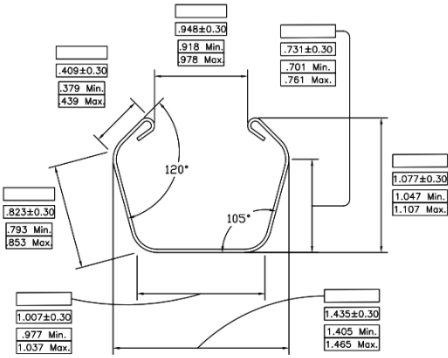
GABLE CLIP

ALUMINUM

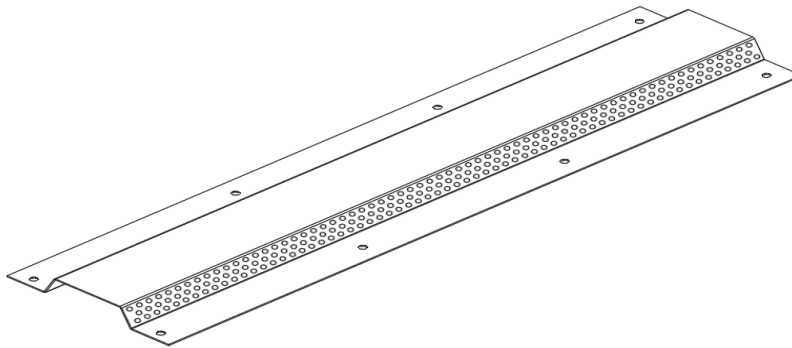
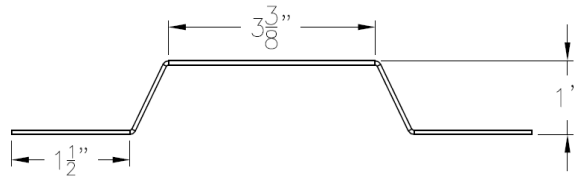


TOP RAIL
