

Administration Schedule – 2010

Examinations may be taken at any of the regular scheduled administrations for any of the counties that GITS, LLC provides examinations for unless the county has specific directions otherwise.

Test may also be taken at the Ocala (Marion County) office of GITS, LLC with a minimum of 24 hours advance scheduling. Scheduling at GITS offices in Ft. Lauderdale, Miami and other in state GITS offices may require a longer lead time if the test is desired on hardcopy (paper) as all printing takes place in Ocala for quality control purposes. Tests are not “stored” at any site for administration purposes except those scheduled during a one week period. Some test administrations may require an additional fee if special arrangements are needed to accommodate the individual taking the examination. No additional fees will be assessed for accommodations that are for documented disabilities.
