### Reasons for Recommendation

An analysis of the factors contained in Section VI D of Implementing Order 3-22 indicate that the following two (2) CSBE Trade Set-Asides are required:

- Trade Set-Aside #1 - Traffic Stripes and Markings: Painted and/or Thermoplastic
- Trade Set-Aside #2 - Concrete: Sidewalk and/or Curb and Gutter

This project is formerly RPQ No. 20120106, which was bid under the MCC 7040 Plan. Bids received were 15.44% over the estimated cost of the project. This project is also formerly RPQ No. 20120162, which is being rejected and re-advertised under RPQ No. 20130163 after SBD deemed each bidder Non-Compliant.
