<p>NO MEASURE - LEASE OF REAL PROPERTY</p> <p>All privately funded construction with a total value over \$200,000 must comply with Sections 10-33.02 and 2-10.4.01 of the Code of Miami Dade County (the "Code"), which govern the County's Small Business Enterprise-Construction (SBE-Construction) and Small Business Enterprise-Architectural & Engineering (SBE-A/E) programs. The Developer shall submit or cause to be submitted the Design and Construction Packages, to the Small Business Development Division of the Internal Services Department ("SBD/ISD") prior to advertisement, for review and determination of appropriate small business program measures, and the application of same. All packages must be advertised and awarded with the applicable small business measures in accordance with the requirements of the above mentioned Code.</p> <p>There are twelve (12) SBE firms certified in the required Commodity Codes.</p> <p>Commodity Code: 57863-Real Estate: Land And Improvements; 91889-Real Estate/Land Consulting (Including Land Survey Consulting); 92561-Land Development And Planning/Engineering</p>



