AXIS COMMUNICATIONS SECURITY CAMERAS SCOPE OF SERVICES

BACKGROUND

The Miami-Dade County Seaport Department (Seaport) is responsible for the operation, administration and maintenance of PortMiami facilities and infrastructure. PortMiami offers services to two dozen of the world's leading cargo lines, reaching some 250 ports in more than 100 countries. In addition to cargo, the PortMiami operates multiple passenger terminals for numerous cruise lines that operate out of Miami-Dade County.

To serve the overwhelming and growing needs of cruise passengers, PortMiami operates four (4) multilevel parking structures and three (3) surface parking lots. The majority of the parking infrastructure is monitored by closed circuit television surveillance through a NICE Video Management System (System), including a fully integrated network consisting of 721 AXIS Communications Security Cameras. Currently, Parking Garage "D" and Surface Lot "E" are not covered by any surveillance or security equipment, therefore creating the need for permanent on-site patrolling.

PortMiami has been awarded grant funds under State of Florida Cargo Security Gateway Grant Contract No. AOI99, Financial Project No. 42053429401 to fund 50% of the cost of the purchase of AXIS Communications Security Cameras to be installed in Parking Garage "D" and Surface Lot "E." Seaport staff will complete the installation of all equipment purchased as a result of this solicitation.
