Business: Must be the principal owner or his/her designee working in the business for a minimum of one year and the business must have been located in the designated area for a minimum of one year.

Education: Must be Lead Administrator or his/her designee working in an educational institution for a minimum of one year and the institution must have been located in the designated area for more than one year.

Faith Community: Must be a Leader or his/her designee of a religious institution for more than one year and the institution must be located in the designated area for more than one year.

Non-profit Organization: Must be an Executive Director or his/her designee working in a non-profit organization for one or more years and the organization must have been located in the designated area for a minimum of one year. Board members of non-profit organizations are ineligible.

General: May be a resident or representative of any group who meets the one year residency or location requirement.
