## **PRESENTATIONS**

Ms. Susanna Arean, MDT provided a presentation on the Miami-Dade Transit Quarterly Transit Performance. The report covered Metrobus, Metrorail, and Metromover mean distance, time performance, and distance between failures.

Mr. Scurr informed the Members that the ordinance change was not passed by the Board of County Commissioners (BCC) on May 4, 2010. Mr. Scurr stated that ordinance change included the five year transportation plan, the process of the CITT reviewing items before the BCC, change the CITT Nominating Committee from 18 organizations to 6 organizations, and having a 1 million dollars delegation on items that will be reviewed by the CITT. Mr. Scurr informed the Members

that the 1 million dollars delegation was removed from the ordinance change by the request of some Members of the BCC. The vote was eight to two but the item needed a two-thirds vote to pass (which is 9 votes).
