The People's Transportation Plan

Summary

This report provides a recap of activities related to the People's Transportation Plan (PTP) for the 90-day period beginning July 1, 2008 through September 30, 2008. Listings of previous and life-to-date accomplishments are available at miamidade.gov/citt.

CITT Member Appointments:

David Concepcion, District 13 was sworn in on July 23, 2008. All seats on the Trust are filled at this time.

CITT Contract Reviews

The following contracts were presented to the CITT for its consideration during this quarter:

- Approving the Board of County Commissioners' (BCC) action, authorizing execution of Amendment No. 1 for \$2,000,000.00 to Contract No. TR04-PTP1 between Miami-Dade County and PB Americas, Inc. (f/k/a Parsons Brinckerhoff Quade & Douglas, Inc.), to provide engineering construction management services, funded in whole by Charter County Transit System Sales Surtax funds (MDT- BCC Legislative File No. 081521)
- Approving the Board of County Commissioners' (BCC) action, authorizing award of competitive contracts with authority to exercise options-to-renew established thereunder, and contract modifications, processed by the Department of Procurement Management (DPM) on behalf of Miami-Dade Transit (MDT), for the purchase of goods and services, in the amount of \$3,072,000.00, funded in part by Charter County Transit System Sales Surtax funds (MDT- BCC Legislative File No. 081893)
- Approving the Board of County Commissioners' (BCC) action, authorizing a contract award recommendation in the amount of \$88,996.00 between Repor Brothers, Inc. and Miami-Dade County for the People's Transportation Plan (PTP) project entitled Country Walk Right-of-Way Improvements, located within Commission District 11 (Project – CICC 7040-0/07 RPQ No. 20070793), funded in whole by Charter County Transit System Sales Surtax funds (PWD- BCC Legislative File No. 081723)

- Approving the Board of County Commissioners' (BCC) action, authorizing a contract award recommendation in the amount of \$795,542.00 between Under Power Corp. and Miami-Dade County for the People's Transportation Plan (PTP) project entitled Street Lighting Installation Contract Countywide - Project – CICC 7360-0/08 RPQ No. 20070601, funded in whole by Charter County Transit System Sales Surtax funds PWD- BCC Legislative File No. 082069)
- Approving the Board of County Commissioners' (BCC) action, authorizing a contract award recommendation for Orange Line Phase 1 – Miami Intermodal Center - Earlington Heights Connector project for construction, engineering and inspection services – Project No. E07-MDT-02, Contract No. NCP004-TR07-CT1, in the amount of \$20,845,995.50, funded in whole by Charter County Transit System Sales Surtax funds (MDT- BCC Legislative File No. 082084)

CITT Resolutions

- Requesting the County Manager not approve or authorize any work orders or expenditures for the Orange Line, other than for the Miami Intermodal Center (MIC-Earlington Heights Connector, under the Professional Services Agreement with PB Americas, Inc.-Contract No. TR04-PTP1
- Expressing its unwillingness to approve any funding for the Orange Line, excepting the Miami Intermodal Center (MIC-Earlington Heights Connector, until Miami-Dade County receives a favorable rating from the Federal Transit Administration (FTA) for its New Starts application for the Orange Line project
- Offering the position of Executive Director of the CITT to Nan Markowitz
- Assigning supervision of the Executive Director to the Chairperson of the CITT and providing that requests of the Executive Director need to be approved by the Chairperson or a majority of the CITT committee involved
- Approving offering a three (3) year employment contract for the Executive Director's position
- Approving an annual evaluation of the Executive Director to be performed by the CITT Chairperson and Vice Chairperson with input by the full Trust

Miami-Dade Transit (MDT) Corridors

MIC-Earlington Heights

- The Project is in the bid and award process for the construction phase. The bid opening was held on August 4, 2008. There were four bids.
- The Construction Engineering & Inspection (CE&I) consultant selection was approved by the BCC on September 2, 2008 and by the CITT Full Trust on September 23, 2008.
- Parcels 155 and 501: The County Attorney's Office (CAO) will present the Negotiated Settlement agreement to the BCC in October 21, 2008
- The 2nd supplemental agreement to the URS contract for Post-Design Services was approved by the Transit Committee on September 10, 2008 and is scheduled for consideration by the BCC on October 7, 2008, CITT Project and Finance Review Committee approval on October 16, 2008 and CITT Full Trust on October 29, 2008.
- The current estimated cost of the project is \$526 million in Year-of-Expenditure (YOE) dollars. The current projected completion date for this project is 2012.

North Corridor

- Published draft of final Supplemental Environmental Assessment (SEA) and held public hearing on September 3, 2008 and concluded public comment period
- FTA advised in the September 8, 2008 teleconference that the Project will not enter Final Design in 2008 and the Financial Capacity Assessment will not be conducted until the financial planning issues are resolved
- Issued Stop Work Order to the Preliminary Engineering (PE) design consultant, utilities and railroads noting that further work tasks will be authorized on a case-by-case basis until approval is received from FTA to allow initiation of Final Design
- Continued negotiations with property owners to gain access to remainder of Phase II Environmental Site Assessments (ESA) for remaining locations
- Finalized spreadsheet that depicts Typical Characteristics and Pros and Cons of different Technologies such as Bus Rapid Transit (BRT), BRT "Lite", Lite Rail Transit (LRT), and Heavy Rail Transit (HRT).
- The current estimated cost of this project is \$1.341 billion in Year-of-Expenditure (YOE) dollars. The current projected completion date for this project is 2017. This date represents a working timeline that will likely be affected by the resolution of the financial plan issues and policy/administrative decisions made by FTA.

East-West Corridor (MIC TO FIU)

- A Supplemental Draft Environmental Impact Statement (DEIS) is underway to update the 1998 Final Environmental Impact Statement (FEIS), along with development of an alignment for Metropolitan Planning Organization (MPO) endorsement as the Locally Preferred Alternative (LPA). MDT is currently studying various alignment options. The Project schedule will be revised to reflect the updated financial plan once it has been adopted. A stop work order was issued to the PE Consultant, HNTB Corporation, on September 10, 2008 to preserve contract resources. Any additional work, such as responding to FTA comments, shall be authorized by MDT on a case-by-case basis.
- The current estimated cost of the project is \$2.5 billion in Year-of-Expenditure (YOE) dollars. The current projected completion date for this project is 2024.

South Dade (MPO Project)

- The South Link Study is complete. The Miami-Dade Metropolitan Planning Organization (MPO) has transferred the project to the MDT Systems Development Division for planning development.

Kendall (MPO Project)

- The Preferred Rapid Transit Strategy has been presented to various MPO committees (Transportation Planning Technical Advisory Committee, Transportation Planning Council, Citizens Transportation Advisory Committee and Transit Subcommittee) for recommendations.
- An expanded Executive Summary has been prepared and posted on the project website.

Baylink (Light Rail to Miami Beach)

- Work on the corridor is on hold. The corridor will be re-evaluated for development with possible funding available commencing in 2016.

Northeast (FDOT Project)

- A sectional Record of Decision (ROD) approval is pending.
- A full Notice-To-Proceed is still pending.
- Completion of a travel survey of potential riders from northern Palm Beach County.
- The Final Programmatic Environmental Impact Statement is in final review and will be submitted to FTA.

Miami-Dade Transit Updates

New Hires:

- In keeping with the PTP's promise of creating more transit-related jobs, MDT has hired two new employees during the fourth quarter of 2008, July 1, 2008 – September 30, 2008, maintaining the total of new hires at 1873 since November 2002.

Buses:

- The MDT current total fleet is 968 buses. Prior to the passage of the PTP, MDT operated 705 buses. Since then, MDT has increased the fleet by 263 buses. The active fleet consists of 756 large 40-foot buses, 13 large 45-foot over-the-road buses, and 122 small 30-foot buses for a total of 891 active buses. Also included in the total fleet are 57 buses placed in inactive status and a contingency fleet of 20 retired buses.

Golden Passport/Patriot Program:

- During the quarter (July 1, 2008 – September 30, 2008), there were 2,494 over 65 Golden Passport cards issued, 1,476 under 65 years of age and 207 Patriot Passport cards. Total new patrons this reporting period 4177. To date, there are 194,147 certified Golden Passport/Patriot Passport Patron accounts.
- In November 2002, there were 55,404 active Golden Passport accounts. From November 2002 to September 2008, there were 138,743 additional Golden and Patriot passports issued, including 36,201 under 65 customers.
- In June 2004, MDT implemented the Patriot Passport for honorably discharged veterans with an income of \$22,000 or less. Currently, 5,708 Patriot Passports have been issued. Currently 2,327 veterans have renewed their Patriot Passport. Renewal process is ongoing.

Public Works Department (PWD)

Advanced Traffic Management System (ATMS):

- PWD continues upgrading and transferring signals onto the new ATMS system. As of September 30, 2008, out of 2602 signalized intersections, 1167 are running ATMS software. The Department continues to working with the consultant Kimley-Horn, upgrading approximately 60 signals per month this quarter.
- The PWD is working closely with each of the County Commissioner's Offices to discuss the Neighborhood Improvement Projects, such as resurfacing, sidewalks, drainage, striping, ADA sidewalks, guardrails, traffic signals, and school flashing signals.
- Since inception, sixty-three (63) PTP open construction contracts (totaling \$60.9 million) have been approved by the CITT and BCC. Each contract has been issued a Notice to Proceed.
- Multiple CICC contracts are also active for various PTP projects. In an effort to accelerate many neighborhood projects, PWD is taking advantage of various contracting mechanisms, such as the Miscellaneous Contracting processes available under CICC contracts 7360 and 7040
- Since the inception of the program, PWD has installed illuminated street name signs at 973 intersections throughout the County, inclusive of fifty-three (53) intersections accomplished under the Pilot Program. PWD, with assistance from FDOT and several municipalities, is working to implement a County-wide program to install LED signs on major intersections over the next three years.

PTP employees hired during the fourth quarter of FY07- 08:

- PWD is hiring staff and acquiring equipment to accelerate the PTP projects effort. During this quarter, one (1) employee vacated a PTP position, keeping the total at forty-nine (49).

PTP Municipal Component – Highlights of accomplishments

Municipal Audits

- Miami-Dade County's Office of Audit and Management (AMS) completed audits for Pinecrest, North Bay Village and Biscayne Park. New audits were commenced for the municipalities of Homestead, Florida City and Hialeah.

Municipal Visits

- In the last quarter, OCITT visited the following municipalities: Bay Harbor Islands, Golden Beach, Coral Gables, Hialeah Gardens, Medley (2), Miami Springs, South Miami, North Bay Village, Pinecrest (2), Palmetto Bay, West Miami, and Miami Lakes.

Municipal Highlights

City of South Miami

The City's Sunset Drive Improvements (SW 62nd Ave to U.S. 1)-Phase I project continues as scheduled. The project includes traffic calming improvements such as the installation of roadway brick pavers, construction of median curbs, sidewalk widening and improvements to pedestrian use such as pedestrian crosswalks, ramps and bus shelters. Completed portions of the project include drainage, streetscape and lighting, and miscellaneous architectural features (clock tower, and water feature) that blend in with the pedestrian friendly project objective. A ribbon-cutting event for completion of the project has been scheduled for Wednesday, October 29, 2008.

City of North Miami

The "NOMI Express", the City's transit circulator, continues to gain in ridership, with a record 18,000 riders in September 2008. This is almost double the ridership from January of this year. In addition, the City has rolled out the new bus wraps that are intended to capture the attention of riders. The wraps reinforce the improved route maps and logo design. The City has allocated money this year for increasing the level of service of the buses and planning for the future of the service.

As was mentioned in the last quarterly report, North Miami was the first municipality in the County to offer subsidized MDT and Tri-Rail passes to its employees. The program started with 13 bus passes in April and this month there are 33 employees taking advantage of this payroll deduction. Instead of paying \$75 for the bus pass, employees pay only \$12.50 per month. We are also offering \$25 off the monthly bus pass for riders of the NOMI Express who receive a coupon redeemable at City Hall. We had planned on selling approximately 20 passes per month; however, 50 passes were sold in June and 100 passes were sold in two days in September. With the increase in MDT rates, the discounted bus passes fill an important affordability gap, while improving a linkage between the NOMI Express and MDT.

City of Coral Gables

The City of Coral Gables has made their trolleys available for private rental. They have become a colorful backdrop for local marketing campaigns. The colorful and vintage-style vehicles have turned into an attractive element for publicists in search of new ways to catch consumers' attention. Recently, a Coral Gables based advertising agency, used the Trolley image to convey the message for the real estate development of Old Spanish Village.

The Trolleys are also going to be used as a promotional element in a future “Green Your Commute” campaign created to save the planet by encouraging commuters to leave cars at home during the week of November 10-14, 2008. The campaign is presented by the City of Coral Gables in cooperation with South Florida Commuter Services to promote the use of alternative modes of transportation as a green initiative.

In addition to becoming available for private rentals, the Trolleys will soon be offering opportunities for paid advertising inside the popular fleet. The City of Coral Gables has contracted with Trolinet, a local company that will produce visual advertising, public service announcements, and content highlighting points of interest of Coral Gables such as restaurants, art galleries, shopping, upcoming events, corporate products, and cultural information. In exchange, the City of Coral Gables will receive ad share revenues.

The Trolleys feature the look of yesteryear with wooden benches and paneled interior, etched windows, and friendly drivers. The vehicles can be rented on weekends or weekdays outside of normal operating hours (Monday through Thursday from 6:30 a.m. to 8 p.m. and Fridays from 6:30 a.m. to 10 p.m.) for \$175 per hour with a minimum of four hours. There are three different size vehicles with a capacity that ranges from 20 up to 35 passengers per vehicle. All rentals are considered on a first-come, first-served basis and the route cannot go beyond a radius of 30 miles around Coral Gables. Current ridership on the Surtax funded circulator surpasses 5,200 boardings daily.

City of Hialeah

The City of Hialeah ordered two new buses to add to their current fleet of nine buses. The new buses are expected to begin service in June of 2009. The City of Hialeah Transit System currently operates two routes (Marlin and Flamingo) and this past September surpassed 51,000 riders for a month for the first time.

Town of Miami Lakes

The Lake Elizabeth Paving and Drainage Improvement Project have been completed. The project addressed drainage deficiencies identified in the storm water master plan. The road received a new asphalt surface and stripping.

The Town received five bus shelters previously ordered in September 2007. Bid documents are prepared for the installation of the bus shelters. The Town is obtaining the necessary building permit for the installation of the bus shelters.

A new bus route is in the planning stage and is expected to be implemented commencing on October 1, 2008

CITT Updates

- The CITT continues to meet regularly to ensure that it is fulfilling its responsibility to “monitor, oversee, review, audit and investigate” the implementation of the PTP. The

Trust met two (2) times during the quarter. A quorum was present at both CITT meetings.

- CITT Committees met on a regular basis during the quarter and, as per their respective subject areas, reviewed items to be forwarded to the full CITT for its consideration. Three (3) CITT Committee meetings took place during the quarter.
- During the quarter, the CITT passed seven (7) resolutions relating to the consideration of PWD and MDT contracts in support of the People's Transportation Plan.

Office of the Citizens' Independent Transportation Trust (OCITT)

Website Updates:

- 32 website updates, revisions, and postings were made to the CITT website during this quarter.

Community Outreach:

CITT members and staff coordinated and participated in community outreach events during the quarter highlighting CITT's role in ensuring proper expenditure of transportation surtax proceeds and implementation of PTP projects:

- CITT staff participated in monthly meetings of the Chamber South Transportation Committee reporting on CITT activities, the municipal program and the status of other PTP projects.
- CITT Chairperson Miles Moss and OCITT staff participated in monthly meetings of the Citizens Transportation Advisory Committee full board and subcommittee responding to inquiries and reporting on CITT activities.
- OCITT published and distributed the CITT newsletter, "CITT Insider" with news and information on the CITT and the PTP.
- OCITT staff participated in the presentation of the STUDY Intern final report to the City of North Miami Community Revitalization Agency.

Compliance and Oversight:

- The committee will continue to monitor and report the status of County contracts pertaining to opportunities generated by the People's Transportation Plan.
- The Small Business Affairs division (formerly Department of Business Development) is a regular attendee/participant at bi-monthly meetings.

- Miami-Dade Transit monitors the status of Surtax funded contracts that include federal funding. To date, MDT reports nine (9) Prime Contractors and fifty-two (52) Subcontractors that are subjected to Disadvantaged Business Enterprises (DBE) compliance measures.

Finance

During the quarter, the OCITT received \$45,145,384 in surtax proceeds, and transferred \$9,137,133 to eligible municipalities as part of the established municipal share.
