The People's Transportation Plan

Summary

This report is presented by the Citizens' Independent Transportation Trust (CITT) with information pertaining to its oversight of the expenditure of proceeds of the Charter County Transit System Sales Surtax and implementation of the People's Transportation Plan (PTP) for the period October 1, 2008– December 31, 2008.

The CITT continues to work closely with members of the Board of County Commissioners (BCC), the County administration, staff at Miami-Dade Transit (MDT) and the Public Works Department (PWD), and the participating municipalities to insure PTP funds are used properly.

Significant improvements have been made to Miami-Dade County's public transit and roadway systems because of the PTP. New buses and Metromover vehicles have been purchased and are in operations. Municipal circulator systems are successfully operating in many of our cities. Hundreds of miles of roadways have been improved, the countywide traffic signalization system is being upgraded and the Metrorail extension to the airport will soon be under construction.

CITT Contract Reviews

A major responsibility of the CITT is to review contracts requesting surtax funding for projects listed in the PTP. These contracts are initiated by Miami-Dade Transit and Miami-Dade Public Works Department and are reviewed by the staff at the Office of the Citizens' Independent Transportation Trust before they are voted on by the Trust.

The following contracts were presented to the CITT for its consideration during this quarter:

CITT Resolutions

The CITT originates resolutions to express the sense of the Trust on important issues such as approval of funding for eligible PTP projects and to provide guidance, insight and opinions to the Board of County Commissioners.

The following resolutions were approved by the CITT during the quarter:

Recommending modification of the Exhibit 1 of the PTP by creating a Capital Expansion Reserve Fund and allowing for greater flexibility in the use of Charter County Transit System Sales Surtax Funds for the operation and maintenance of the transit system

Amending the By-Laws of the Citizens' Independent Transportation Trust (CITT)

Recommending the removal of the Rehabilitation of Metrorail Cars from the list of projects included in Exhibit 1 of the PTP

Appointing Charles D. Scurr as Interim Executive Director of the Office of the Citizens' Independent Transportation Trust (OCITT)

Requesting that the BCC amend the proposed amendment to Exhibit 1 of the PTP as outlined in Citizens' Independent Transportation Trust (CITT) resolution 08-079 by establishing a three year sunset provision for said PTP amendment

Requesting the BCC amend the proposed ordinance amending Section 29-124 of the Code of Miami-Dade County, Florida by requiring a two-thirds vote of the BCC membership to reject or modify the recommendation of the CITT

Recognizing and commending CITT member Jorge E. Cueto for exceptional service and commitment to the CITT and to the implementation of the PTP upon his resignation to become a Circuit Court Judge

Miami-Dade Transit Update

Miami-Dade Transit (MDT) is responsible for implementing all County transit improvements in the PTP including Metrobus, Metrorail and Metromover projects and the Golden Passport Program.

MDT reports the following activities related to PTP projects during this quarter:

Metrobus - MDT has increased the Metrobus fleet by 262 buses since the PTP was passed; the current Metrobus fleet is 967 buses. The Active Fleet consists of 759 40-foot buses, 13 45-foot over-the-road buses, and 121 30-foot minibuses for a total of 893 active buses. Also included in the Total Fleet are 56 buses placed in inactive status and a contingency fleet of 18 retired buses.

Active Fleet: 893 buses, Inactive Fleet: 56 buses and Contingency Fleet: 18 buses = Total Fleet: 967 buses

PTP Staff—MDT had no new hires during the period covering October - December 2008, maintaining the total of new hires to 1874 since November 2002.

Golden Passport/Patriot Program—MDT issued 1,562 over 65 years of age Golden Passport cards, 1,101 under 65 years of age and 205 Patriot Passport cards during the quarter. To date, there are 173,314 certified Golden Passport/Patriot Passport Patron accounts. From November 2002 to December 2008, there were 135,696 additional Golden and Patriot passports issued; including 34,071 under 65 customers.

Miami-Dade Public Works Department Update

The Miami-Dade Public Works Department (PWD) is responsible for developing and implementing PTP funded roadway projects including paving, bike paths, lighting, drainage, curb cuts, guard rails, signage and traffic signals.

Advanced Traffic Management System (ATMS) - PWD continues upgrading and transferring signals onto the new ATMS system. As of December 31, 2008, 1325 of 2602 signalized intersections are running ATMS software. The Department continues to working with the consultant, Kimley-Horn, in upgrading approximately 70 signals per month this quarter.

Neighborhood Improvement Projects - The PWD is working closely with each of the County Commissioner's Office to discuss Neighborhood Improvement Projects, such as resurfacing, sidewalks, drainage, striping, ADA sidewalks, guardrails, traffic signals, and school flashing signals.

PTP Funded Construction Contracts - Since the inception of the PTP, sixty five (65) PTP funded construction contracts, totaling \$62.4 million, have been approved by the CITT and BCC. A Notice to Proceed has been issued for each project.

Capital Improvement Construction Contract (CICC) Program– Multiple CICC contracts are active for various PTP projects. In an effort to accelerate many neighborhood projects, PWD is taking advantage of various contracting mechanisms, such as the Miscellaneous Contracting processes available under CICC contracts 7360 and 7040.

Illuminated Street Name Signs - PWD has installed illuminated street name signs at 973 intersections throughout the County, including 53 intersections accomplished under the Pilot Program. PWD, with assistance from the Florida Department of Transportation (FDOT) and several municipalities, is working to implement a County-wide program to install LED signs on major intersections over the next three years.

PTP Staff - PWD is hiring staff and acquiring equipment to accelerate the PTP projects effort. Two (2) new PTP employees have been hired during this quarter for a total of fifty-one (51).

PTP Municipal Component

Twenty percent of the annual Surtax proceeds are allocated to thirty-one municipalities eligible to receive PTP funds; each receives a pro rata share based on its population. These funds are used to develop local transit and transportation projects. Following are highlights of municipal activities during this quarter.

The **Village of Palmetto Bay** entered into an Interlocal Agreement with the **Town of Cutler Bay** to provide shuttle bus service from December 9th, 2008 through January 9th, 2009. The Town of Cutler Bay covered all operational expenses for this service allowing the Village of Palmetto Bay to offer free rides to its residents. Soaring gas prices and convenient service patterns accounted for a near doubling of passenger traffic on Palmetto Bay's intra-village bus service in the last six months.

The **City of Coral Gables** initiated an advertising program for the Coral Gables Trolley, which allows advertisers to buy space on the vehicles; this includes completing a new "Trolley Guide," installation of on-board media screens, and other miscellaneous items. The City expects to complete all reviews and installations by the end of the 2nd Quarter.

North Miami Beach completed the roadway resurfacing project for NE 171 Street from NE 15 Avenue to NE 19 Avenue along with the on-street parking project at NE 167 Street; the parking project added twenty (20) on-street parking spaces on the south side of NE 167 Street. In addition, two new bus shelters are in the pre-construction and preparation phase; when completed, they will be located on Biscayne Boulevard at the intersection of NE 140 Street. The City's circulator bus which operates Monday through Friday is now connects with the municipal shuttles of the **City of Aventura** and the **City of Sunny Isles Beach** at selected transit stops.

The **City of Sweetwater** continues to operate a circulator bus service weekdays and weekends serving nine (9) bus stops and serves major activity centers throughout the City. Ridership has increased to approximately 230 passenger boardings a day compared to 200 last guarter.

North Miami marked significant advances in its transportation program by creating a more bicycle-friendly environment using PTP dollars. NE 135th Street in the Arch Creek Neighborhood, east of Biscayne Boulevard, now has the first dedicated bicycle lane running adjacent to the Boulevard. The neighborhood also has a newly milled and repaved road that was previously bumpy and uneven. FDOT funding will allow the bicycle lane to continue through an environmental preserve and link to Florida International University's beautiful bicycle path along Biscayne Bay. This bicycle path is the first leg in the updated Bicycle Network Plan which was made possible with PTP funding, leveraged with an MPO grant. The Network Plan is just one component of a Bicycle Parking/Transit Feasibility Study currently under way and expected to be completed next quarter.

North Miami's transit circulator, called the NOMI Express, reports average monthly boardings of 18,000 riders. Through its participation in the MDT Corporate Pass programs and the Tri-Rail pass program, the City uses PTP funds to subsidize to provide discounted monthly passes to 42 employees. The City is also encouraging transit ridership with its "NOMI Connections" program, whereby NOMI Express riders receive a \$25 discount on County transit passes.

CITT Updates

The CITT continues to meet regularly to ensure that it is fulfilling its responsibility to "monitor, oversee, review, audit and investigate" the implementation of the PTP.

- The Trust met four (4) times during the quarter
- CITT Committees met five (5) times on during the quarter to review agenda items and reports that were forwarded to the full CITT for its consideration.
- During the quarter, the CITT passed seven (7) resolutions

Office of the Citizens' Independent Transportation Trust

The Office of the Citizens' Independent Transportation Trust (OCITT) is the County department that provides professional administrative staff support to the CITT.

Community Outreach:

OCITT staff coordinates and comprehensive public outreach program which includes participation in community outreach events, publication of the informational newsletter and updating the CITT web page to insure all information is relevant and current.

Compliance and Oversight:

The committee will continue to monitor and report the status of County contracts with measures pertaining to opportunities generated by the People's Transportation Plan.

The Small Business Affairs division is a regular attendee/participant at bi-monthly meetings

MDT monitors the status of Surtax funded contracts that include federal funding. To date, MDT reports eleven (11) Prime Contractors and fifty-two (52) Subcontractors that are subject to Disadvantaged Business Enterprises (DBE) compliance measures.

Finance

Transportation surtax funds are collected by the State of Florida and transferred to the County on a monthly basis, OCITT staff manages the disbursement of these funds to eligible entities for the CITT.

During the quarter, the OCITT received \$43,004,816 in surtax proceeds, and transferred \$8,094,183 to eligible municipalities as part of the established municipal share.
