RESOLUTION NO. R-1034-14

RESOLUTION CODESIGNATING SW 56 STREET (MILLER DRIVE) FROM SW 102 AVENUE TO SW 107 AVENUE AS "DANNY A. PINO WAY"

WHEREAS, Daniel A. Pino was born in Miami-Dade County on April 29, 1995, and throughout his life he dreamed of serving his country and becoming a professional baseball player; and

WHEREAS, at the early age of six, after the terrorist attacks on September 11, 2001, Danny knew he wanted to serve his country; and

WHEREAS, Danny's other passion was baseball, which he played his entire life, including for St. Timothy Catholic School, the Boys and Girls Club of Kendall, Belen Jesuit Preparatory School, and all four of his years at Coral Reef Senior High School; and

WHEREAS, during his senior year of high school, Danny was scouted to play baseball for the United States Merchant Marine Academy (USMMA), and he played there while he attended the Academy; and

WHEREAS, after one year Danny decided to return home to study at Florida International University and join the Reserve Officers' Training Corp. (ROTC) in pursuit of his biggest dream, serving his country; and

WHEREAS, Danny received his ROTC uniform on September 11, 2014, which according to him was the happiest day of his life, exactly thirteen years from the day that had originally changed his life so many years ago; and

WHEREAS, in late September 2014, Danny was accidentally struck by a car, and although he fought valiantly for his life for a week, he passed away on September 28, 2014; and

WHEREAS, Danny loved and was loved, and he touched the hearts and lives of everyone he met, more than anyone realized; and

WHEREAS, Danny's final act of valor was donating his organs to two boys, ages seven and 12, and a 63-year-old man, making this his ultimate gift and legacy; and

WHEREAS, St. Timothy Catholic School had a special place in Danny's heart, since he attended the school from Pre-K4 until 6th grade, was a member of their baseball team, and received his Baptism, First Communion and Confirmation at St. Timothy Catholic Church; and

WHEREAS, St. Timothy Catholic School is located at 5400 SW 102 Avenue; and

WHEREAS, this Board would like to honor the memory of Danny A. Pino by codesignating SW 56 Street (Miller Drive) from SW 102 Avenue to SW 107 Avenue as "Danny A. Pino Way"; and

WHEREAS, SW 56 Street (Miller Drive) from SW 102 Avenue to SW 107 Avenue is a County road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed codesignation is located in County Commission District 10,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates SW 56 Street (Miller Drive) from SW 102 Avenue to SW 107 Avenue as "Danny A. Pino Way".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade County Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Senator Javier D. Souto. It was offered by Commissioner **José "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Esteban L. Bovo, Jr.** and upon being put to a vote, the vote was as follows:
