**1. LUCIE Q. JOSEPH (09-023)**

Location: 11020 NW 2 Court, Miami-Dade County, Florida (65.19' X 171')

The applicant is requesting an unusual use to permit a day care center, and to permit the day care center setbacks to be less than required from property lines. The applicant is also requesting to permit a 2-way drive with less width than required, & to permit an accompanying request(s), on this site.

**2. MILO & ASSOCIATES OF MIAMI, INC. (09-063)**

Location: Lying north of NW 58 Street and approximately 160' west of NW 27 Ave, Miami-Dade County, Florida (40' X 129')

The applicant is requesting to permit a parcel of land with less lot frontage than required, on this site.

**3. MIAMI-DADE COUNTY PUBLIC WORKS DEPARTMENT (09-073)**

Location: Between NW 37 Avenue and NW North River Drive and approximately 170' south of the centerline of NW 36 Street, Miami-Dade County, Florida (1 Acre)

The applicant is requesting to waive the zoning regulations width requirements; to permit 0' of dedication along a portion of NW 37 Avenue, on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications.

Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
