### **1. SONIA J. SANGUINETTI (08-131)**

Location: 13505 SW 82 Terrace, Miami-Dade County, Florida (96.78' X 100').

The applicant is requesting to permit a bathroom and a covered terrace additions to a single-family residence to be setback less than required from property lines, on this site.

### **2. GHOLAM & TERESA AZADBAKHT (08-157)**

Location: 4221 SW 134 Avenue, Miami-Dade County, Florida (85' X 100').

The applicants are requesting to permit a shed and a covered terrace addition to a single-family residence to be setback less than required from property lines, and to permit the shed to be spaced less than required from the residence. Also requesting to permit an accompanying request(s), on this site.

Multiple members of individual community councils may be present.

All persons are entitled to attend and to speak at zoning hearings. However, the courts have ruled that it is improper to contact a Board member individually, either orally or in writing, about zoning applications. Those items not heard prior to the ending time for this meeting, will be deferred to the next available zoning hearing meeting date for this Board.
