

## Human and Social Services Community-Based Funding Request for Proposals No. CB01516

Miami-Dade County is soliciting proposals to disburse County General Funds for human and social services for county residents. Eligibility to apply for this funding is limited to 501(c)(3) not-for-profit organizations.

Private (not-for-profit) providers are needed to provide services in the following Service Priority Areas: 1) Children, Youth and Families; 2) Special Needs; 3) Criminal Justice; 4) Elder Needs; 5) Basic Needs; 6) Children and Adults with Disabilities; 7) Anti-violence Initiatives; 8) Preventative Health; 9) Immigrants/New Entrants; 10) Workforce Development; and 11) Other, including Community Economic Development.
