## MIAMI-DADE COUNTY PROCEDURES FOR NON-REGISTERED THIRD-PARTY ORGANIZATIONS Florida Statute 97.0575, Rule 1S-2.042 F.A.C.

(Rev. January 2025)

Dear Concerned Citizen:

Thank you for contacting our office to request voter registration applications. Our office will gladly provide you with the applications as long as you follow procedures for Third Party Organizations outlined in *F.S.* 97.0575 and *Rule* 1S-2.042.

If you are seeking to register to vote or collect a voter registration application from your spouse, child, or parent; or if you are engaged in registering to vote or collecting voter registration applications as an employee or agent of the Division of Elections (DOE), Supervisor of Elections, Department of Highway Safety and Motor Vehicles, or as an official voter registration agency designated by the National Voter Registration Act or State Law (sections 97.021 & 97.058, Florida Statutes), you <u>do not</u> need to register with the State as a Third-Party Organization (3PVRO in short).

However, pursuant to *F.S.* 97.0575 and *Rule* 1S-2.042, any person, entity, or organization that solicits or collects any voter registration application, other than what is stated above, **<u>must</u>** register with the State as a 3PVRO and be **<u>approved</u>** by such before our office is able to provide you with any voter registration applications.

Additionally, if you are a candidate, political committee, or political party who solicits for collection or collects voter registration applications from Florida voter registration applicants, the candidate or entity **<u>must</u>** register and be **<u>approved</u>** as a 3PVRO.

If you want to become a 3PVRO, you must register with the State by submitting Form DS-DE 119. You may visit the State's website at <u>Third-Party Voter Registration Organizations (3PVRO) - Division of Elections - Florida Department of State</u> for more information and to obtain Form DS-DE 119.

Once registered as a 3PVRO, you may request voter registration applications pre-printed with your 3PVRO's identification number by sending an email to <u>3PVRO@votemiamidade.gov</u> at least five business days in advance from the date of your event. This will give us enough time to have the applications pre-printed with your 3PVRO's identification number. When doing so, please identify the 3PVRO identification number of your organization, along with the quantity and type of applications needed (English, Spanish, or Creole). If any request exceeds 9,999 voter registration applications, the 3PVRO must request the applications through the Florida Division of Elections.

Placing orders for voter registration applications in advance whenever possible gives us sufficient time to ensure applications for your organization are ready in time. Thank you for your consideration and best wishes for such a worthwhile endeavor.
