3. Resident of District at least six (6) months prior to qualifying.

TERM: The unexpired portion of the current term for County Commissioner – District 5, commencing upon certification of the election through Tuesday, November 17, 2020.

TERM LIMIT: Two (2) terms [\[Miami-Dade County Charter, Article 3, Section 3.01\(E\)\]](#)
No person shall be elected as Commissioner for more than two consecutive four-year terms. No term of service as a Commissioner commencing prior to 2012 shall be considered a part of or counted toward the two term limit.

SALARY: \$6,000 Annually [\[Miami-Dade County Charter, Article 1, Section 1.06\]](#)

ELECTION DATES: Tuesday, May 22, 2018
Tuesday, June 19, 2018 (should a run-off election be required)

QUALIFYING DATES: Noon, Thursday, April 5, 2018 through 5:00 p.m., Saturday, April 14, 2018

(Filing fee of \$300.00 plus an election assessment equal to 1% of the annual salary as of July 1, 2017).
