AN INSPECTION WILL BE PERFORMED BY THE FIRE PREVENTION INSPECTOR. A PERMIT WILL NOT BE ISSUED WITHOUT AN APPROVED INSPECTION OF THE BURN SITE PERFORMED BY THE FIRE PREVENTION DIVISION (786.331.4800). A CHECK/MONEY ORDER MUST BE INCLUDED WITH THE APPLICATION FOR BURN PERMIT. **AN INSPECTION WILL NOT BE CONDUCTED UNTIL PAYMENT IS RENDERED.** (A PRE-INSPECTION IS REQUIRED PRIOR TO ISSUANCE OF ANY BURN PERMIT).

NOTE: PLEASE CHECK ALL APPLICABLE AREAS. ALL ITEMS RELATING TO EACH APPLICABLE SECTION MUST BE COMPLIED WITH TO OBTAIN **AND RETAIN** A PERMIT. ADDITIONAL FEES WILL BE IMPOSED IF ADDITIONAL INSPECTIONS ARE REQUIRED.



OPEN BURN PERMIT

GENERAL



- THERE WILL BE NO BURNING OF RESIDENTIAL TRASH, CONSTRUCTION DEBRIS, COPPER WIRE OR TREATED WOOD
- THERE WILL BE NO PLASTICS MIXED WITH THE VEGETATION TO BE BURNED
- THERE WILL BE NO DEBRIS TRANSPORTED INTO ANY BURN SITE
- THE FIRE COMMUNICATIONS OFFICE (786-268-6635) WILL BE CALLED EACH DAY PRIOR TO BURNING FOR APPROVAL
- ALL REASONABLE PRECAUTIONS WILL BE TAKEN TO PREVENT EXCESSIVE VISIBLE EMISSIONS AND ODORS (PUBLIC NUISANCE) DURING BURNING
- ALL REQUIRED EQUIPMENT AND WATER SUPPLIES WILL BE ON SITE AND OPERATIONAL FOR THE DURATION OF THE BURN
- THE BURN WILL BE SUPERVISED AND CONSTANTLY ATTENDED
- THE BURN PERMIT WILL BE KEPT ON THE BURN SITE WHILE BURNING

BONFIRES



- ALL PUBLIC ROADS MUST BE AT LEAST ONE HUNDRED (100) FEET AWAY FROM BURN SITE
- ALL OCCUPIED BUILDINGS MUST BE AT LEAST ONE HUNDRED (100) FEET AWAY FROM BURN SITE
- PILE SIZE MUST BE NO GREATER THAN EIGHT (8) FEET HIGH, LONG OR WIDE
- NO UTILITY LINES CAN BE LOCATED OVERHEAD
