<b>Product Description</b> (Identify Subset or Total Database):
<b>Type of Subscription:</b> A Weekly subscription is delivery of the Product Update to Subscriber as of Monday of each week. It includes all basic GIS datasets distributed in shape file format, including our Base Maps (lots, parcels, subdivision and zoning). Note: Subscription Fees are subject to change each fiscal year (October thru September)
<b>Special Conditions:</b> This GIS Data Subscription Agreement is subject to the Terms and Conditions listed below.
<b>Annual Subscription Fee (Weekly Update):</b> \$2,000.00

- A. Term.** The term of this subscription agreement (Subscription) shall commence the date Miami-Dade County receives this signed Subscription until terminated by the terms of this Subscription.
- B. Delivery of Initial Product.** For and in consideration of the Subscriber's agreement to make payments and perform other obligations under this Subscription, within 14 days of receipt of Subscriber's payment to initiate this Subscription the County agrees to deliver the Product by FTP (file transfer protocol) or as otherwise requested by parties in writing.
- C. Automatic Renewal of Subscription, Payment & Delivery of Product Updates.** Subscriber agrees that its Weekly Subscription as chosen above will be automatically renewed and Subscriber agrees to pay the invoiced subscription fee within 30 days of receipt of the invoice and Product Update. Product Updates will be delivered using the same delivery method as agreed upon in the Section B above. Product Updates will be provided through delivery of the entire Product with changes incorporated and no attempt to identify actual changes is expressed or implied through this Subscription. Subscriber shall not use the Product Update for which no subscription fee was paid.
- D. Termination.** Subscriber may terminate this Subscription by giving the County written notice to the address above 30-days prior to Subscriber's next subscription update delivery date. This Subscription is automatically terminated if Miami-Dade County does not receive full payment for the Product Update within 60 days from the date of the invoice under which the Product Update was sent. The county may terminate this Subscription at any time, with or without cause, by giving written notice to Subscriber at the address above.
