RESOLUTION NAMING A BOXING RING AT THE DR. MICKEY DEMOS AMATEUR BOXING CENTER AT TROPICAL PARK AS THE "DR. MARTINIANO ORTA BOXING RING"

WHEREAS, Dr. Martiniano Orta, born in Havana, Cuba, practiced medicine in Miami-Dade County for several decades as a board certified cardiologist; and

WHEREAS, Dr. Martiniano Orta participated in the sport of boxing in his capacity as a ringside fight doctor; and

WHEREAS, Dr. Martiniano Orta was championship boxer Roberto Duran's (a/k/a Manos de Piedras) ringside physician; and

WHEREAS, Dr. Martiniano Orta recently passed away; and

WHEREAS, this Board desires to honor Dr. Martiniano Orta by naming a boxing ring at the Dr. Mickey Demos Amateur Boxing Center in Tropical Park in his honor; and

WHEREAS, the Dr. Mickey Demos Amateur Boxing Center is located in Commission District 10,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board finds that Dr. Martiniano Aorta had a personal, direct and meaningful relationship to Miami-Dade County and is worthy of recognition by this Board.

Section 2. This Board hereby names a boxing ring at the Dr. Mickey Demos Amateur Boxing Center in Tropical Park as the "Dr. Martini no Aorta Boxing Ring."
