RESOLUTION APPROVING THE PLAT OF PRECIOUS EXECUTIVE HOMES,
LOCATED IN THE NORTHEAST 1/4 OF SECTION 2, TOWNSHIP 56 SOUTH,
RANGE 39 EAST (SW 184 STREET AND SW 127 AVENUE)

WHEREAS, Mangrove Development of Miami, Inc., a Florida corporation, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as PRECIOUS EXECUTIVE HOMES, the same being a replat of Lot 1 of "Tropico", according to the plat thereof, as recorded in Plat Book 2, at Page 57, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 2, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights of way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.


