GRANDPARENT PROGRAM

RECOMMENDATION


It is recommended that the Board approve the attached resolution, which authorizes the County Manager to apply for, receive and expend Corporation for National Community Services funds in the approximate amount of \$460,196 to continue the administration and operation of the Foster Grandparent Program for the Community Action Agency. The program year is January 1, 2005 through December 31, 2005.

BACKGROUND

Resolution No. R-1404-03 authorized funding in the amount of \$479,914 for the Foster Grandparent Program for the year ending December 31, 2004. The total funding from all sources for the year ending 2004 is \$624,380. The number of unduplicated clients to be served in the 2004 program year is 500 children and 120 volunteers. The new funding cycle is effective January 1, 2005 through December 31, 2005. Anticipated funds for the program are: Federal \$460,196; County \$69,650; in-kind \$94,534; totaling \$624,380. County funds are provided for in the budget. The total administrative cost attributed to the proposed funding period is \$206,403.

Foster Grandparent volunteers serve children at Jackson Memorial Hospital, several public schools with the Exceptional Student Education Program, four daycare centers and the Head Start Program. The program will provide part-time volunteer opportunities for 101 low-income persons, at the approximate cost of \$4,556 age sixty (60) and older to render supportive services to approximately 500 children with special needs. The volunteers work with children who are under 18 years of age, five (5) days a week, four (4) hours each day with the same two children.

The benefits provided to the Foster Grandparent Program volunteers are: stipend of \$2.65 per hour, transportation allowance through CAA, daily hot meal, annual physical exam, social services, information and referral, and recreational activities. The benefits to the recipients are: person to person supportive services including personalized care, educational services and recreational activities to help the children grow physically, socially, emotionally and mentally.




It is recommended that the Board approve the attached resolution, which authorizes the County Manager to apply for, receive and expend Corporation for National Community Services funds in the approximate amount of \$479,914 to continue the administration and operation of the Foster Grandparent Program for the Community Action Agency. If funded, the effective date of the program will be January 1, 2004 through December 31, 2004.

BACKGROUND

Resolution No. R-1110-00 authorized funding in the amount of \$1,270,554 for the Foster Grandparent Program for a three (3) year period ending December 31, 2003. The new funding cycle is for one year, effective January 1, 2004 through December 31, 2004. Anticipated funds for the program are: Federal \$479,914; County \$64,650; in-kind \$81,162; totaling \$625,726. County funds are provided for in the budget. The total administrative cost attributed to the proposed funding period is \$190,144.

Foster Grandparent volunteers serve children at Jackson Memorial Hospital, several public schools with the Exceptional Student Education Program, four daycare centers and the Head Start Program. The program will provide part-time volunteer opportunities for 104 low-income persons, at the approximate cost of \$5,739, age sixty (60) and older to render supportive services to children with special needs. The volunteers work with children who are under 18 years of age, five (5) days a week, four (4) hours each day with the same two children.

The benefits provided to the Foster Grandparent Program volunteers are: stipend of \$2.65 per hour, transportation allowance through CAA, daily hot meal, annual physical exam, social services, information and referral, and recreational activities. The benefits to the recipients are: person to person supportive services including personalized care, educational services and recreational activities to help the children grow physically, socially, emotionally and mentally.
