

Subject: Countywide In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration.

Background

The South Florida Golf Foundation, a not-for-profit organization, for the Ford Championship at Doral PGA Tour Event held on February 26 through March 6, 2005, is requesting a retroactive waiver for in-kind services.

In-kind services have been requested in the amount of \$22,890 from Miami-Dade Fire Rescue for fire rescue and fire watch services. Funding for this in-kind request does not affect the countywide in-kind reserve.

In FY 2004-05, South Florida Golf Foundation has not received any County funding.
