RESOLUTION RETROACTIVELY AUTHORIZING FEE WAIVER FROM THE MIAMI-DADE PARKS AND RECREATION DEPARTMENT FOR THE APRIL 18, 2005 AMIGOS TOGETHER FOR KIDS, INC.'S BLUE RIBBON EVENT IN AN AMOUNT NOT TO EXCEED \$3000.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

**WHEREAS**, Amigos Together for Kids, Inc. has requested a fee waiver from the Miami-Dade Parks and Recreation Department for the April 18, 2005 Blue Ribbon Event in an amount not to exceed \$3000.00 (see attached Fee Waiver/In-Kind Service Application); and



The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends the item move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Amigos Together for Kids, Inc. for their Amigos for Kids Blue Ribbon Campaign Event held on April 18, 2005 at the Miami-Dade County Auditorium.

In-kind services have been requested in the amount of \$3,000 from the Park and Recreation Department for the rental fee and admission fees of the Miami-Dade County Auditorium for approximately 1500 people. This event will be funded from the countywide in-kind reserve funds.

In FY 2004-05, Amigos for Kids received \$50,000 from the general fund as part of the FY 2004-05 Adopted Budget and \$10,000 from the District 6 Discretionary Reserve.
