

RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE POLICE DEPARTMENT AND MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE UNITED CHINESE ASSOCIATION OF FLORIDA'S OCTOBER 15-16, 2005 THIRD ANNUAL SOUTH FLORIDA DRAGON BOAT FESTIVAL IN AN AMOUNT NOT TO EXCEED \$14,800.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND AND IN PART FROM THE FIRE RESCUE DISTRICT BUDGET

WHEREAS, the United Chinese Association of Florida has requested in-kind services from the Miami-Dade Police Department and Miami-Dade Fire Rescue Department for the October 15-16, 2005 Third United Chinese Association of Florida in an amount not to exceed \$14,800.00 (see attached Fee Waiver/In-Kind Service Application); and

WHEREAS, the South Florida Dragon Boat Festival is a Countywide event, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund and from the Fire Rescue District budget,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes in-kind services from the Miami-Dade Police Department and the Fire Rescue Department for the October 15-16, 2005 Third United Chinese Association of Florida in an amount not to exceed \$11,600.00 to be funded from the Countywide In-kind Reserve Fund and \$3,200.00 to be funded from the Fire Rescue District budget.







 Park Marina will be two miles on the right hand side.



Subject: Countywide In-Kind Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

The United Chinese Association of Florida, a not-for-profit organization, is requesting in-kind services for their 3rd Annual South Florida Dragon Boat Festival scheduled for October 15-16, 2005.

In-kind services have been requested in the amount of \$3,200 from the Miami-Dade Fire Rescue Department for their ALS Unit and \$11,600 from the Miami-Dade Police Department for landside and waterside assistance, for a total in-kind request of \$14,800. The in-kind services provided by the Miami-Dade Fire Rescue Department do not affect the countywide in-kind reserve. The countywide in-kind reserve will fund \$11,600 for police services.

In FY 2005-06 the United Chinese Association of Florida has not received any County funding.
