



Subject: District Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

West Miami Middle School is requesting a waiver for in-kind services for their Green & Gold Games scheduled for December 16, 2005.

In-kind services have been requested in an amount of \$3,232 from the Park and Recreation Department for use of four sets of bleachers. This event will be funded from the District 6 district specific in-kind reserve.

In FY 2005-06 West Miami Middle School has not received any County funding.
