

RESOLUTION URGING THE U.S. CONGRESS TO EXPAND  
THE CHILD TAX CREDIT AND EARNED INCOME TAX  
CREDIT

**WHEREAS**, Miami-Dade County and other metropolitan areas around the country have many families and children living in poverty; and

**WHEREAS**, the Child Tax Credit and Earned Income Tax Credit are widely credited with helping lift families and children out of poverty every year,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Urges the U.S. Congress to expand the Child Tax Credit and Earned Income Tax Credit.

**Section 2.** Directs the Clerk of the Board to transmit a certified copy of this resolution to the members of the Miami-Dade County Congressional Delegation.

**Section 3.** Directs the County's federal lobbyists to advocate for the passage of the legislation set forth in Section 1 above, and directs the Office of Intergovernmental Affairs to include this item in the 2007 Federal Legislative Package.
