

ORDINANCE AMENDING ORDINANCE NO. 02-225  
CREATING THE JAY MALINA INTERNATIONAL TRADE  
CONSORTIUM OF MIAMI-DADE COUNTY (ITC);  
PROVIDING FOR THE APPOINTMENT, TENURE AND  
REMOVAL OF MEMBERS; ORGANIZATION OF THE ITC;  
AND SPECIFYING POWERS AND DUTIES OF THE ITC;  
PROVIDING SEVERABILITY, INCLUSION IN THE CODE,  
AND AN EFFECTIVE DATE

**BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF  
MIAMI-DADE COUNTY, FLORIDA:**

Section 1.      Section 9 of Ordinance 02-225 is hereby amended to read as follows:<sup>1</sup>

ORDINANCE NO. 02-225

ORDINANCE CREATING THE JAY MALINA  
INTERNATIONAL TRADE CONSORTIUM OF MIAMI-DADE  
COUNTY (ITC); PROVIDING FOR THE APPOINTMENT,  
TENURE AND REMOVAL OF MEMBERS; ORGANIZATION  
OF THE ITC; AND SPECIFYING POWERS AND DUTIES OF  
THE ITC; PROVIDING SEVERABILITY, INCLUSION IN THE  
CODE AND AN EFFECTIVE DATE

Sec. 9.      This ordinance shall (remain in effect until  
repealed) ~~[[sunset on December 31, 2006]]~~.

<sup>1</sup> Words stricken through and/or ~~[[double bracketed]]~~ shall be deleted. Words underscored and/or >>double arrowed<< constitute the amendment proposed. Remaining provisions are now in effect and remain unchanged.

Section 2. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 3. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance, including any sunset provision, shall become and be made a part of the Code of Miami-Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

Section 4. This ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become effective only upon an override by this Board.
