The attached Professional Services Agreement between H.J. Ross Associates, Inc. and Miami-Dade County has been prepared by Miami-Dade Transit (MDT) and is incorporated by reference herein and is recommended for approval.

**PROJECT:** Design of Pedestrian Overpasses at South Miami and University Metrorail Stations

**PROJECT LOCATION:** South Miami Metrorail Station  
University Metrorail Station

**PROJECT DESCRIPTION:** Professional Services Agreement (PSA) to design and prepare a set of biddable construction documents for each new pedestrian overpass at the following locations: U.S.-1 at the South Miami Metrorail Station and U.S.-1 University Metrorail Station.

The scope of work includes design, public involvement activities, preparation of a complete set of biddable construction documents, technical specifications and the preparation of the engineer's estimate of probable construction cost for each new pedestrian overpass. The scope of work shall include all the necessary coordination with all involved agencies and organizations, including but not limited to, Miami-Dade Transit (MDT), Miami-Dade Public Works (PWD), Florida Department of Transportation (FDOT), pertinent municipalities and institutions and all the appropriate permitting agencies. Elements of the work include, but are not limited to, architecture, surveying, right of way issues, soils investigation, structures, utility identification and relocation, lighting, landscaping, maintenance of traffic, environmental studies and environmental mitigation plans, as required.

MDT will include an option in the contract to provide final design services for additional locations that are identified in the People's Transportation Plan (PTP). MDT will also include an option to provide design services during construction as well as an option to provide construction, engineering and inspection (CE&I) services at all locations, at MDT's sole discretion.

The two (2) overpasses included in this contract were incorporated in the listing of Capital Improvement Projects included as part of the People's Transportation Plan, adopted by the Board on October 9, 2003 through Resolution No. R-1154-03. A federal grant was secured for the South Miami Pedestrian Overpass to include its design. The design of the University Pedestrian Overpass will be funded by surtax backed bonds.

Since proceeds from the Charter County Transit System Sales Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County may be used to pay for all or some part of the cost of this contract, no award of this contract shall be effective and thereby give rise to a contractual relationship with the County unless and until the following have occurred: 1) the County Commission awards the contract, and such award becomes final (either by expiration of 10 days after such award without veto by the Mayor, or by Commission override of a veto); and, 2) either, i) the Citizens' Independent Transportation Trust (CITT) has approved same, or, ii) in response to the CITT's disapproval, the County Commission reaffirms its award by two-thirds (2/3) vote of the Commission's membership and such reaffirmation becomes final.

**JUSTIFICATION:**

A Notice to Professional Consultants (NTPC) was advertised on April 21, 2006. There were twelve (12) proposals submitted on May 19, 2006, in response to the NTPC. First and Second Tier meetings were conducted and a selection was made. The Selection Committee, appointed by the County Manager, recommended that negotiations be conducted with H.J. Ross Associates, Inc. The County Manager concurred with the Selection Committee and on July 25, 2006, the first negotiation meeting was held.

The negotiated scope includes:

- o Final design services including preparation of biddable construction documents for each new pedestrian overpass at the following locations: U.S.-1 at South Miami Metrorail Station and U.S.-1 at University Metrorail Station.

This contract also includes options to provide final design services for additional locations that are identified in the People's Transportation Plan (PTP), as well as options to provide design services during construction and construction, engineering and inspection (CE&I) services. It is estimated that Final Design Services for each additional location could be in the range of \$315,000 to \$465,000 depending on the complexity of the pedestrian bridge.

In the event the County decides to exercise these options, the work will be negotiated and authorized through the issuance of a work order after the approval of a supplemental agreement by the Board.

The Request-to-Advertise approved by the County Manager on April 18, 2006, included an original cost estimate in the amount of \$682,000. However, this original cost estimate did not include several activities that were made part of the final negotiated scope of work for this contract. Some of the activities not considered in the original cost estimate include, but are not limited to: Project Control activities, Quality Assurance, Concept Refinement, Landscape Architecture and preparation of project newsletters. Throughout the negotiation process, the Negotiation Committee felt that the above mentioned activities were necessary for the implementation of the project and approved these activities as part of the final negotiated scope of work.

After numerous negotiation sessions, the Negotiation Committee arrived at a not-to-exceed number it believed to be fair and reasonable for final design services for the pedestrian overpasses at the South Miami and University Metrorail Stations. Based on the above, it is recommended this agreement be awarded in the not-to-exceed amount of \$781,650.40 to H.J. Ross Associates, Inc.

The final design of these two overpasses is expected to be completed in late spring 2008 and the Construction is expected to be completed in late spring 2010.





In response to the County Manager's Memorandum approved July 17, 2006 the designated Negotiations Committee conducted the process of negotiations for the subject project. Attached, for your approval, is a Non-exclusive Professional Services Agreement with the following Consultant Team:

**GENERAL DESCRIPTION OF THE PROJECT**

The services requested include the design and preparation of a set of biddable construction documents for new pedestrian overpasses at the following locations: U.S.-1 at University Metrorail Station and U.S.-1 at South Miami Metrorail Station.

**TOTAL COST AND SOURCE OF FUNDING**

Total amount under this Agreement is limited to a maximum of \$781,650.40, which includes an allowance account of ten percent (10%) in the amount of \$68,786.40 for all services described in the General Description of the Project. This amount also includes three dedicated accounts for surveying services, geotechnical services and reimbursable expenses totaling an amount not to exceed \$25,000.00. The total cost of services will be defrayed from funds allocated for that purpose by Miami-Dade Transit from federal sources, state sources and the County's Sales Surtax for Transportation.

**SELECTION PROCESS**

The Consultant Selection process was conducted in accordance with Administrative Order 3-39 of the Code of Miami-Dade County, as authorized by the County Manager's memorandum dated May 11, 2006. The designated Consultant Selection Committee (CSC) met on June 12, 2006 to prescreen consultants. The prescreening process included the review of the material submitted by twelve (12) teams of firms in response to the public notice. As a result of the prescreening process, the top five (5) teams were invited to the Second Tier Meeting with oral presentations on June 29, 2006.

As a result of the Second Tier Meeting, the CSC unanimously concurred to proceed to negotiations with the highest-ranking team of H.J. Ross Associates, Inc. The CSC recommendations were submitted to the Office of the County Manager on July 3, 2006. The Negotiation Committee, appointed by the County Manager, undertook and successfully completed negotiations of the attached Agreement on September 6, 2006.

#### NEGOTIATION PROCESS AND CONSULTANT FEES

The first negotiation meeting with the Consultant was held on July 25, 2006 to discuss the scope of work. Further negotiation meetings were conducted on August 10, 2006, August 22, 2006, September 6, 2006, and November 8, 2006 to discuss the Consultant's Proposals received on August 8, 2006, August 18, 2006, and August 31, 2006. At these meetings the items discussed were: further clarifications in the scope of work, level of effort required to perform the work, reasonable staff/labor hours needed to perform each task, number of sheets needed to be produced for each discipline and direct reimbursable expense items. The maximum allowed direct hourly rates, principals' rates, office overhead, and multipliers were also approved by the negotiation committee.

At the September 6, 2006 meeting, the negotiation committee passed a motion to approve the total amount of 6,635 hours and three dedicated accounts for surveying services, geotechnical services and reimbursable expenses totaling an amount not to exceed \$25,000.00. On September 13, 2006 the negotiation committee approved the final scope received by the consultant on September 11, 2006. On November 8, 2006, the negotiation committee approved the certified overhead rate for the prime consultant. The final certified overhead rates for the sub-consultants were received from the consultant on January 3, 2007. The negotiation committee approved the total amount for this Agreement not to exceed \$781,650.40, which includes an allowance account of ten percent (10%) in the amount of \$68,786.40 for all services described in the General Description of the Project. This amount also includes three dedicated accounts for surveying services, geotechnical services and reimbursable expenses totaling an amount not to exceed \$25,000.00.

A Disadvantage Business Enterprise (DBE) utilization goal of twenty percent (20%) has been established for this contract.

#### TIMETABLE

Upon final execution of this professional Services Agreement, the agreement shall remain in full force and effect for a period of sixty (60) months. This Agreement will be administered by MDT on a Work Order basis.

If negotiations are proceeding within a reasonable timeframe, then negotiations are to continue and the report is to be submitted upon completion.
