



RESOLUTION CODESIGNATING SW 37<sup>TH</sup>  
AVENUE FROM SW 28<sup>TH</sup> STREET TO SW 23<sup>RD</sup>  
TERRACE AS JUAN M. SORONDO, M.D. AVENUE

**WHEREAS**, this Board has conducted a public hearing to consider codesignating SW 37<sup>th</sup> Avenue from SW 28<sup>th</sup> Street to SW 23<sup>rd</sup> Terrace as Juan M. Sorondo, M.D. Avenue; and

**WHEREAS**, Juan M. Sorondo, M.D. was born in Havana, Cuba, on December 27, 1947; and

**WHEREAS**, Juan M. Sorondo's, M.D. undergraduate training was at Coral Gables High School, 1964, Miami Dade Community College, A.A., Honors, 1966, University of Miami, B.S., Cum Laude and General Honors, 1968, Coral Gables, Florida; and

**WHEREAS**, Juan M. Sorondo, M.D. earned his medical degree in 1972 from University of Miami School of Medicine and has since presented more than 40 lectures throughout the United States; and

**WHEREAS**, Juan M. Sorondo, M.D. did both internship and residency at Jackson Memorial Hospital, (1973 and 1974) Miami, Florida, Mount Sinai Medical Center, Chief Resident, 1975, Miami Beach, Florida, Gastroenterology Fellowship, Mount Sinai Medical Center, 1976 and 1977, Miami, Florida; and

**WHEREAS**, Juan M. Sorondo, M.D. is a member of the Medical Society American College of Gastroenterology, American College of Physicians, American Society for Gastrointestinal Endoscopy, Florida Gastroenterological Society; and

**WHEREAS**, Juan M. Sorondo's, M.D. has conducted significant research in the area of diagnosis of pancreatic tumors, the treatment of pancreatic carcinoma, and celiac axis compression syndrome; and

**WHEREAS**, this proposed codesignation is located in County Commission District 7,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that:

Section 1. This Board finds that Juan M. Sorondo, M.D. has made a direct, significant lifetime contribution to this community.

Section 2. By three-fifths of the Board Members present, this Board approves the co-designation of SW 37<sup>th</sup> Avenue from SW 28<sup>th</sup> Street to SW 23<sup>rd</sup> Terrace as Juan M. Sorondo, M.D. Avenue.

Section 3. The Clerk of the Board is hereby directed to transmit a certified copy of this resolution to the United States Postal Authority, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Police Department, and the Fire Department.
