Subject: Project Award Recommendation in the Amount of \$189,259.59 Between All Quality Electrical Services, Inc. and Miami-Dade County for the People's Transportation Plan (PTP) Project Entitled Traffic Signal Installation at West 24 Avenue and West 76 Street in Commission District 12 (**Project – CICC 7360-0/08 RPQ No. 20060342**)

Recommendation

The attached Project Award Recommendation for the Traffic Signal Installation at West 24 Avenue (NW 82 Avenue) and West 76 Street (NW 130 Street) in Commission District 12 (Project – CICC 7360-0/08 RPQ No. 20060342), in the amount of \$189,259.59, between All Quality Electrical Services, Inc. and Miami-Dade County has been prepared by the Public Works Department (PWD) and is recommended for approval. Proceeds from the Charter County Transit System Sales Surtax (the Surtax) will be used to fund this project, therefore, approval by the Board of County Commissioners (BCC) and Citizens' Independent Transportation Trust (CITT) is required.

Scope

The proposed improvements qualify under the allowable work categories included in the People's Transportation Plan (PTP) Neighborhood Improvements Section. Specific funding for this project will be allocated from the Commission District 12 PTP yearly allocations.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$189,259.59 and will be funded from the Surtax.

Track Record/Monitor

The OCI database lists six (6) awarded contracts for All Quality Electrical Services, Inc. However, since the contractor is new to the Department, there are no listed contractor performance evaluations on file, since the contracts are still under construction or in the preliminary stages. However, the contractor is currently performing work for PWD at a satisfactory level as reported by the Project Manager.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. Throughout all PTP projects, the responsible staff person in PWD will continue to be the PTP Coordinator, Mr. David Tinder, P.E. Following completion of the award process, the project will be assigned to Mr. Oscar Rubio, Project Manager, for day to day responsibilities.

According to the Florida Department of State, Division of Corporations, All Quality Electrical Services, Inc., Company Principals are: Samuel Lightbourne and Shakira Lightbourne and the Company's address is listed as: 14500 NW 16th Court, Miami, Florida 33167.

Background

In an effort to accelerate the continued success of the PTP Neighborhood Improvements initiative, PWD is taking advantage of various contracting mechanisms, such as the subject Miscellaneous Construction Contracting (MCC) process available under the Office of Capital Improvements (OCI) contract CICC 7360-0/08. Through this process, PWD forwards the Request for Price Quotation (RPQ), by way of facsimile transmission and US-mail, to a pool of firms that have registered with OCI for the subject trade. Additionally, PWD advertises the project in the Daily Business Review as well as providing courtesy notifications in the Diario De Las Americas, Miami Herald, Miami Times, Haiti en Marche, Le Floridien, and Kiskeya Herald. Interested contractors prepare their bids according to the Job Order Contracting (JOC) process, whereby the County establishes unit prices for the pay items in accordance with industry averages. The contractors submit their bid as an overall percentage factor of the pricing established by the County. The project award evaluation is based upon the lowest percentage submitted by the responsive, responsible bidder for the project.

PWD staff submitted the referenced project to the Department of Business Development's (DBD) Review Committee. The Review Committee met on December 13, 2006, reviewed RPQ 20060342 and recommended no contract measures for this project. Therefore, on December 14, 2006, PWD issued an RPQ for a Traffic Signal Installation Contract and forwarded it to a list of 11 pre-registered firms from the OCI database as noted above. Six (6) firms purchased contract documents and three (3) firms proffered a bid. As a result, on January 18, 2007, PWD issued a recommendation of award for RPQ 20060342 with a percentage factor of 0.95 to All Quality Electrical Services, Inc. with the stipulation that approval of this project must be obtained from the BCC and the CITT due to guidelines associated with the funding source.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, and equipment and tools to perform traffic signal installation(s) including any ancillary work at the intersection of West 24 Avenue and West 76 Street. The contractor shall furnish and install grounding electrodes, conduits, pull boxes, foundations, eight (8) pedestrian countdown signals, four (4) pedestrian detectors with push buttons and signs, overhead signs (internally illuminated LED signs), mounting hardware, signal cable, power cable and power services. Additional work to be performed includes installing six (6) vehicle detection loops, four (4) traffic signal poles, signage, new pavement markings, sidewalks, curb and gutter and removing existing signs and old pavement markings in conflict with the proposed work. The base contract amount is \$164,676.34, but the total allocated amount is \$189,259.59, which is inclusive of the contingency and dedicated allowances.



This letter will serve as your notification that you have been recommended for award for the above referenced RPQ based on your Price Quotation submitted on Wednesday, January 10, 2007. The total RPQ amount is one hundred eighty-nine thousand two hundred fifty-nine dollars and fifty-nine cents (\$189,259.59). This includes a base contract amount of one hundred sixty four thousand six hundred seventy six dollars and thirty four cents (\$164,676.34), a contingency amount of sixteen thousand four hundred sixty eight dollars and twenty five cents (\$16,468.25), and dedicated allowances totaling eight thousand one hundred fifteen dollars and zero cents (\$8,115.00). The contract duration is 180-calendar days. However, the award is contingent upon the submission of the required items listed below:

Further, it shall be understood that since proceeds from the Charter County Transit System Sales Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County may be used to pay for all or some part of the cost of this contract, no award of this contract shall be effective and thereby give rise to a contractual relationship with the County unless and until the following have occurred: 1) the County Commission awards the contract, and such award becomes final (either by expiration of 10 days after such award without veto by the Mayor, or by Commission override of a veto); and 2) either i) the Citizens' Independent Transportation Trust (CITT) has approved same, or ii) in response to the CITT's disapproval, the County Commission re-affirms its award by two-thirds (2/3) vote of the Commission's membership and such reaffirmation becomes final.




