

RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE FIRE RESCUE DEPARTMENT FOR THE MARCH 20-25, 2007 WORLD GOLF CHAMPIONS - CA CHAMPIONSHIP SPONSORED BY THE SOUTH FLORIDA GOLF FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$25,000.00 TO BE FUNDED FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT BUDGET

**WHEREAS**, the South Florida Golf Foundation, Inc. has requested in-kind services from the Miami-Dade Fire Rescue Department for the March 20-25, 2007 World Golf Champions – CA Championship in an amount not to exceed \$25,000.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the South Florida Golf Foundation, Inc. is a not-for-profit organization; and

**WHEREAS**, the World Golf Champions – CA Championship is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and the purpose of the event is to raise money for the 1st Tee Chapter of Miami-Dade and other local Florida charities; and

**WHEREAS**, the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District Budget,
