

RESOLUTION APPROVING THE WAIVER OF PLAT OF VICTOR HEIGHTS, LLC, D-22472, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 36, TOWNSHIP 54 SOUTH, RANGE 40 EAST (SW 80 STREET AND SW 63 COURT)

WHEREAS, Victor Heights, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as Lot 1, Block 1 of "Victor Heights", according to the plat thereof, as recorded in Plat Book 58, at Page 83 of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 36, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


