

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT, THE MIAMI-DADE POLICE DEPARTMENT, THE MIAMI-DADE FIRE RESCUE DEPARTMENT, AND THE DEPARTMENT OF SOLID WASTE MANAGEMENT FOR THE FEBRUARY 10-17, 2007 "MEMORIAL CUBANO" SPONSORED BY MEMORIAL CUBANO, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$32,190.81 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE DISTRICT IN-KIND RESERVE FUND

WHEREAS, Memorial Cubano, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department, the Miami-Dade Police Department, the Miami-Dade Fire Rescue Department, and the Department of Solid Waste Management for the February 10-17, 2007 "Memorial Cubano" event in an amount not to exceed \$32,190.81 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Memorial Cubano" event is a simulated cemetery in which all the victims of the Cuban communist regime as of January 1, 1959 are honored; and

WHEREAS, Memorial Cubano, Inc. is a not-for-profit organization; and

WHEREAS, the "Memorial Cubano" event is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$20,236.56 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund, \$11,954.25 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department the Miami-Dade Police Department, the Miami-Dade Fire Rescue Department, and the Department of Solid Waste Management for the February 10-17, 2007 "Memorial Cubano" event in an amount not to exceed \$32,190.81 to be funded in part from the Countywide In-kind Reserve Fund, and in part from the non-ad valorem portion of the Fire Rescue District In-kind Reserve Fund.

The foregoing resolution was sponsored by Commissioner Joe A. Martinez, Commissioner Jose "Pepe" Diaz, Commissioner Carlos A. Gimenez, Commissioner Rebeca Sosa and Senator Javier D. Subject: Countywide In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization El Memorial Cubano for their annual memorial event held on February 10-17, 2007.

In-kind services have been requested in an amount not to exceed \$8,420.56 from the Miami-Dade Police Department (MDPD), \$11,954.25 from the Miami-Dade Fire Rescue Department (MDFR), \$10,020 from the Park and Recreation Department and \$1,796 from the Department of Solid Waste Management for a total in-kind amount of \$32,190.81. The in-kind services provided by MDFR, \$11,945.25, will be funded by from the Fire District in-kind reserve fund. The remaining balance of \$20,236.56 will be funded from the countywide in-kind reserve fund.

In FY 2006-07 Memorial Cubano has not received any County funding.
