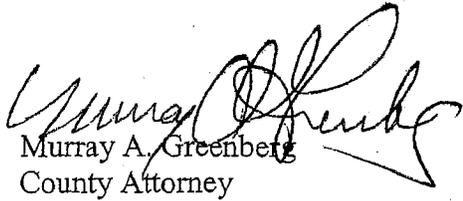

WHEREAS, Talbert E. Linwood and Yolette Linwood, husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Tract 814 of "Biscayne Gardens, Section D", according to the plat thereof, as recorded in Plat Book 44, at Page 36, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 24, Township 52 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

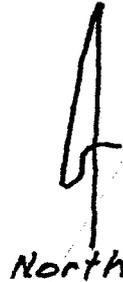

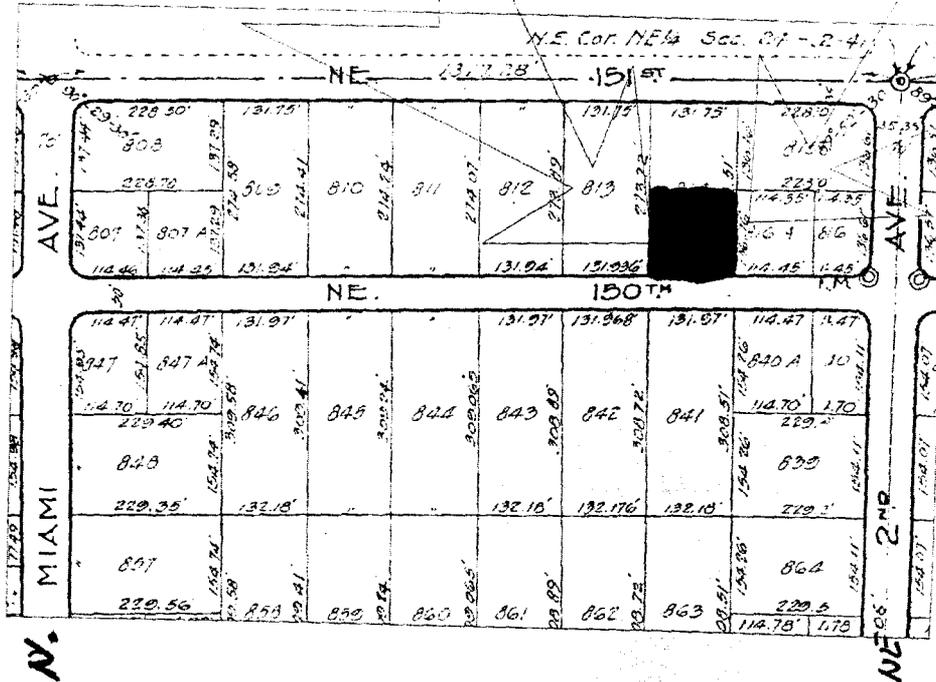
