## RECOMMENDATION

It is recommended that the Board adopt the attached resolution ratifying the actions of the County Manager, pursuant to provisions of the Aviation Department's Expedite Ordinance No. 95-64, codified as Section 2-285 (6) of the Miami-Dade County Code, in accepting and executing a Supplemental Joint Participation Agreement (SJPA) No. 1 between Miami-Dade County and the State of Florida Department of Transportation (FDOT), relating to milling and overlaying of certain taxiways and aprons at Opa-locka Executive Airport (OPF) under Financial Project Number 42155319401, in the additional funding amount of \$619,420.

## SCOPE

This project associated with this SJPA is located within Commission District One, Barbara J. Jordan. However, the impact of this project is Countywide in nature as Opa-locka Executive Airport is a regional asset.

## FISCAL IMPACT

This SJPA represents an additional \$619,420 in FDOT funding for the subject project.

## BACKGROUND

The Aviation Department has identified various surface pavement deficiencies in taxiways and aprons at OPF. These pavement surfaces date back to the 1950's and are in need of prompt repair through a milling of their surfaces and overlaying them with new asphalt.

By Resolution No. R-127-07, the Board approved a Joint Participation Agreement in the amount of \$140,000 for this project. FDOT has offered to increase its funding for the project by \$619,420 for a total FDOT funding of \$759,420. FDOT's grant funds will come from \$14,442,000 of FY 06-07 state funds already offered by FDOT to Miami-Dade County for development, construction, and planning costs at the County's airports. The milling and asphalt overlay project is included in the Board approved Capital Improvements Program.



**RESOLUTION RELATING TO OPA-LOCKA EXECUTIVE AIRPORT; RATIFYING COUNTY MANAGER'S EXECUTION PURSUANT TO THE PROVISIONS OF SECTION 2-285(6) OF THE MIAMI-DADE COUNTY CODE, OF A SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT NO. 1 WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) UNDER WHICH FDOT'S FUNDING WILL BE INCREASED BY \$619,420 FOR FINANCIAL PROJECT NUMBER 42155319401**

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum and document, copies of which are incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board approves, ratifies, and confirms the actions of the County Manager, pursuant to the provisions of Section 2-285(6) of the Miami-Dade County Code, in accepting and executing a Supplemental Joint Participation Agreement (SJPA) Number 1 under Financial Project Number 42155319401 between Miami-Dade County and the Florida Department of Transportation (FDOT) under which FDOT's funding for the project at Opa-locka Executive Airport involving the milling and overlay of taxiways and aprons, as reflected in the SJPA attached hereto and made a part hereof, is increased from the original funding in the amount of \$140,000 by the sum of \$619,420 for a total FDOT funding of \$759,420 for Financial Project Number 42155319401.


