

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE JUNE 16, 2007 ANNUAL FAMILY DAY EVENT SPONSORED BY THE MIAMI NORTHSIDE OPTIMIST CLUB, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$866.00 TO BE FUNDED FROM THE DISTRICT 2 IN-KIND RESERVE FUND

**WHEREAS**, the Miami Northside Optimist Club Inc., has requested in-kind services from the Miami-Dade Park and Recreation Department for the June 16, 2007 Annual Family Day event in an amount not to exceed \$866.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the Annual Family Day event provides an opportunity for the Optimist Club to give back to the community and allow residents to learn about the recreational community programs offered at the center; and

**WHEREAS**, the Miami Northside Optimist Club, Inc., is a not-for-profit organization; and

**WHEREAS**, the Annual Family Day is a small event, as defined in the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the District 2 In-kind Reserve Fund,

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Miami Northside Optimist Club, Inc. for their "Annual Family Day" event held on June 16, 2007.

In-kind services have been requested in an amount not to exceed \$866 from the Miami-Dade Park and Recreation Department for use of their 24 x 40 stage and sound system. This event will be funded from District 2 in-kind reserve fund.

In FY 2006-07, the Miami Northside Optimist Club, Inc. has not received any County funding for this event.
