



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE APRIL 8, 2007 EASTER COMMUNITY CELEBRATION SPONSORED BY MIAMI BETHANY COMMUNITY SERVICES, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,450.00 TO BE FUNDED FROM THE COUNTYWIDE IN-KIND RESERVE FUND

**WHEREAS**, Miami Bethany Community Services, Inc., has requested in-kind services from the Miami-Dade Parks and Recreation Department for the April 8, 2007 Easter Community Celebration in an amount not to exceed \$3,450.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the Easter Community Celebration is a free event and the purpose of this event is to serve over 4,000 low-income individuals by screening and enrolling them into Medicaid, the Food Stamp Program, Earned Income Tax Credit Program; and

**WHEREAS**, Miami Bethany Community Services, Inc., is a not-for-profit organization; and

**WHEREAS**, the Easter Community Celebration is a special event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and the in-kind services shall be funded from the Countywide In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Parks and Recreation Department for the April

They will also have the opportunity of enjoying of special youth and children presentations for all ages that will include live music, dances and dramas allegorical to the season. Lunch will be provided during the event for all attendees. MBCS will create a database to keep on serving all low income families by providing them with a variety of services like a weekly box of food including all first need daily items, clothing, After School and Summer Camp services for their children, prevention programs for at high risk youth among others. This event is also being supported by 150+ volunteers of Miami Bethany Church of the Nazarene which will be in charge of the meals preparation and distribution, logistic, artistic performances, audiovisual, decoration, etc. All services will be provided free of charge for the participants during the event and afterward.

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

## Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization Miami Bethany Community Services, Inc. for their Easter Community Celebration held on April 8, 2007 at the Miami-Dade County Auditorium.
