**Haulover Park & Marina will be two miles on the right hand side.**




The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

## Background

A waiver for in-kind services has been requested by a not-for-profit organization the Miami Overseas Chinese Association the "Water Sporting" event held on December 8, 2007.

In-kind services have been requested in an amount not to exceed \$1,050 from the Miami-Dade Park and Recreation Department for use of a 24 x 40 stage and set of bleachers. This event will be funded from the District 4 in-kind reserve fund.
