CRITICAL LEGISLATIVE PRIORITIES

Home Rule and Preemption: SUPPORT the preservation of local home rule; and OPPOSE any effort to preempt local authority.

State Funding and Cost Shifts: SUPPORT the preservation of funding for all county programs; and OPPOSE any additional cost shifts from the state to the county, and any reduction in county revenue, revenue sharing, or funding from the state.

Miami-Dade Doc Stamps – SUPPORT the extension of the Miami-Dade County documentary stamp surtax program that is dedicated to affordable housing.

Sadowski Act Cap Repeal - SUPPORT elimination of the cap on the Sadowski Act Trust Funds for affordable housing.

FDOT New Starts Program – SUPPORT full funding of the New Starts Program of the Florida Department of Transportation to ensure the funding of the Orange Line MetroRail Extension.

Beach Erosion Control - SUPPORT full funding for Beach Erosion Control to restore eroded segments of shorelines, thus re-establishing storm protection and recreational benefits in the project site.

CRITICAL APPROPRIATION PRIORITIES

Miami River Dredging Federal Advance - \$7.5 million

SUPPORT a \$7.5 million funding request for Miami River Dredging – Federal Channel Advance to complete the dredging project.

Jackson Health System Indigent Care - \$20 million

SUPPORT a \$20 million funding request for JHS to provide charity care to indigent patients.

Emergency Watch System – \$2 million

SUPPORT a \$2 million funding request for an Emergency Watch System that will facilitate communication between various public safety agencies (35 cities and the County) and the state warning point on major incidents as they occur.

Jail Diversion Gap Funding - \$270,000

SUPPORT a \$270,000 funding request for a Jail Diversion Gap Funding to replenish a pool of funds to provide immediate access to housing and behavioral health services for individuals with serious mental illnesses being released from jail and awaiting approval of entitlement benefits such as Social Security.

Dually Diagnosed HART - \$479,610

SUPPORT a \$479,610 request for the addition of 18 specialized residential treatment beds for the Homeless Assessment, Referral and Tracking Program (HART) of the Homeless Trust.

Elderly High Risk Nutritional Meals - \$871,250

SUPPORT an \$871,250 funding request for meals to seniors at least 60 years of age or older who have been determined to have a nutritional score of 5.5 or higher as determined by the state.

DEPARTMENTAL LEGISLATIVE REQUESTS

BUILDING CODE COMPLIANCE OFFICE

Inactive Permits - SUPPORT legislation that would make state licensed contractors responsible for inactive permits by allowing governmental agencies responsible for code enforcement and building code issues to issue state licensed contractors citations on these inactive permits

Florida Building Code and Product Approval - MONITOR legislation regarding the Statewide Product Approval Process and Florida Building Code.

CONSUMER SERVICES

For Hire Transportation Preemption - OPPOSE legislation relating to For Hire Transportation which would impact the County's authority to approve or restrict transfers of taxicab, jitney, limousine, or other passenger vehicle for-hire licenses.

Moving Company Preemption - MONITOR legislation that affects the County's ability to regulate moving companies.

Towing Company Preemption - MONITOR legislation that affects the County's ability to regulate towing companies.

Tour Guides as Sellers of Travel Preemption - SUPPORT legislation that would remove the preemption of County governments from regulating tour guides as a seller of travel, or in the alternative, remove "tour-guide services" from the definition of "sellers of travel" under all sections of Florida Statute 559.

Consumer Services Regulated Industries - MONITOR legislation that affects the following County regulated industries: motor vehicle repair; moving; locksmith; towing; wrecker; motor vehicle title loan; vehicle immobilization; general consumer protection; for-hire transportation vehicles, including taxicabs, limousines and ambulance service.

CORRECTIONS AND REHABILITATION

Arrest Authority for Correctional Officers - SUPPORT legislation that would allow correctional officers limited arrest authority within County jail detention facilities and their surrounding perimeter.

Blue Lights for Correctional Agency Vehicles - SUPPORT legislation that would allow vehicles owned, operated, or leased by the Department of Correction or any County Correctional Agency to show or display blue lights when responding to emergencies.

COMMUNITY REDEVELOPMENT AGENCY (CRA)

Ex-Military Facilities in CRA - SUPPORT legislation that would amend the Community Redevelopment Act to modify the criteria for the creation of a CRA in areas that include land previously used as a military facility.

CULTURAL AFFAIRS

Cultural Affairs Funding - SUPPORT increasing statewide budget allocation for cultural affairs programming, cultural facilities and regional cultural facilities grants through the Florida Department of State Division of Cultural Affairs.

ELECTIONS

HAVA Funds - SUPPORT the release of funds awarded to the State of Florida for mandated voting equipment changes through the Help America Vote Act (HAVA).

Early Voting Sites - SUPPORT legislation that would allow the Supervisor of Elections to use any site convenient and accessible for early voting, and includes the required security protocol.

Early Voting Hours for Local Elections - SUPPORT legislation that would allow the Supervisor of Elections to provide early voting with the discretion of assigning the hours of operations in county elections that are not held in conjunction with state or federal elections.

EMERGENCY MANAGEMENT

Emergency Generators - SUPPORT legislation that would provide for enforcement and penalties for non-compliance with HB 2171 (2006) with regard to generators at fuel stations and multi-story dwellings.

ENVIRONMENTAL RESOURCES MANAGEMENT (DERM)

Beach Erosion Control - SUPPORT full funding for Beach Erosion Control to restore eroded segments of shorelines, thus re-establishing storm protection and recreational benefits in the project site.

FIRE RESCUE

Impersonating Fire Fighters - SUPPORT legislation that would prohibit the impersonation of Fire Fighters with criminal punishment.

Water Wells - SUPPORT legislation that would include funding of water well in the Urban Development Boundary to protect public health or environment.

EMS License fees -- SUPPORT a proposed change to State Statute 401.34 that is seeking to increase EMS licensing fees.

HOMELESS TRUST

Sadowski Act Cap Repeal - SUPPORT elimination of the cap on the Sadowski Act Trust Funds for affordable housing.

HOUSING AGENCY

Public Safety Grants for Public Housing -- SUPPORT dedicated funding for public safety grants to law enforcement agencies for public housing security upgrades and enhancements.

HUMAN SERVICES

Subsidized Child Care/School Readiness - SUPPORT funding from the state Agency for Workforce Innovation to allow maintenance of effort and/or enhancement funding for child care/school readiness programs.

LIBRARIES

State Aide to Libraries - SUPPORT an increase of \$3.25 million for state aid to libraries.

OFFICE OF STRATEGIC BUSINESS MANAGEMENT (OSBM)

Revenue Cap for Expanded Taxing Districts - SUPPORT legislation that ensures taxing districts that expand due to annexation or consolidation do not have their revenues capped at pre-existing levels.

PLANNING AND ZONING

Coastal High Hazard Comp Plan Compliance - SUPPORT legislation for a change of date for local compliance from July 1, 2008 to July 1, 2009 for the comprehensive plans for the Coastal High-Hazard Area.

POLICE

Predatory Lending - SUPPORT legislation that would identify and define predatory lending and create criminal penalties for violations thereof.

Impersonating Police Officer - SUPPORT legislation that would make falsely personating a police officer a second degree felony or if the commission of a felony results in the death or personal injury of another human being making that charge a first degree.

SEAPORT

Strategic Intermodal System - MONITOR any bills, rules, regulations and statewide policies involving transportation intermodal issues including but not limited to major transportation improvement projects as defined in the State Strategic Intermodal System as it relates to access to and from the Port of Miami.

Sunshine State Loan Program - SUPPORT the Florida Ports Council's efforts in securing dedicated funding sources for Florida seaports through the Sunshine State Loan Program, and continued funding support from other Florida Department of Transportation (FDOT) funds to assist the Port in its capital improvement projects; including security operations and capital improvements at the Port.

Seaport Security - MONITOR legislation imposing new security mandates on Florida Ports that both positively and negatively effect operations.

SENIOR ADVOCATE

Community Care for the Elderly – SUPPORT additional CCE funding to lead agencies in the community will reduce the County's waiting list of Homecare and Adult Day Care.

Alliance for Aging, Inc. "Aging Resource Center Model" – SUPPORT state funding for the Aging Resource Center in Miami-Dade County.

SOLID WASTE MANAGEMENT

Renewable Energy - SUPPORT legislation for the preservation and enhancement of existing initiatives that support the production of the "renewable" energy produced at the county's Resources Recovery Facility from the combustion of municipal solid waste.

Enhanced Illegal Dumping Penalties - SUPPORT legislation regarding the Florida Litter Law requiring that the illegal dumping violation should result in the revocation of the driver's license, in addition to the current vehicle seizure provision.

Used Electronics - SUPPORT efforts of DEP for increased regulation of used electronics in the waste stream and to insure that such legislation does not place a disproportionate burden on local government for segregation, collection and recycling and management of this waste stream

relative to other responsible parties, such as the state, the electronics manufacturers and retailers, private waste facilities and generators.

Disposal Fee Equity - OPPOSE legislation requiring the Counties provide certain waste management services at no cost or at reduced cost and/or any legislation seeking to regulate user fees charged.

Local Solid Waste Programs Grant Funding - SUPPORT the allocation of waste-related grants in a County by County basis at a level commensurate with the amount of fees paid into the mitigation fund by the residents of each County.

WATER AND SEWER

Ocean Outfalls – MONITOR legislation that would require utilities to provide advanced wastewater treatment, such as nutrient removal, prior to discharging through a deep ocean outfall; and OPPOSE any legislation that is not supported by proven scientific data.

Water Resource and Alternative Water Supply Development - SUPPORT legislative action expanding the definition of water resource development to include desalination (including brackish groundwater or surface water) and regional/multi-jurisdictional water facilities; Water conservation or demand side management programming that results in long-term water savings should be defined as an alternative water supply and be eligible for grants under the Alternative Water Supply Grants Program. OPPOSE any legislation which establishes a statewide Water Commission which redefines the water supply relationship among the State, WMDs and local governments; and Florida Public Service Commission (PSC) oversight of local and regional water utilities.

Alternative Water Supply Funding – SUPPORT legislative and administrative action to support the continuation of partnerships between the State, WMDs and local water utilities to significantly increase the funding of alternative water supply development; increased funding for the alternative water supply development cost-share grant program using dedicated State and WMD funding; which provides an equitable, cost effective distribution of funds among all types of alternative water supply projects (i.e., reservoirs, aquifer storage and recovery, reuse, and desalination (brackish groundwater or surface water, and seawater), regardless of the size of the water utility, that addresses both regional and/or local needs in a cost effective manner; and a reduction in the maximum utility contribution to no more that fifty percent.

Water Governance - OPPOSE legislation that preempts local control over feasibility, reuse, water pricing and comprehensive planning activities.

Linking Water Supply and Growth - SUPPORT establishment of a base percentage rate for each WMDs budget to fund alternative water supply projects; require WMDs dedicate a percentage of their annual growth in ad valorem tax revenues to these projects; increase State and WMDs financial support to assist local and regional water utilities with future alternative water supply development.

Water Conservation - SUPPORT legislative action to amend State water law that recognizes that local and regional water utilities have the responsibility and right to establish rates and rate structures for their services; which mandates DEP to develop and implement a statewide comprehensive "goal-based" water conservation program; and encourage water conservation efforts, while allocating state resources made available through Water Protection and Sustainability Program Trust Fund of DEP. MONITOR proposed legislation on water reservations, continue evaluating the process of developing such reservations and assess the potential impacts to the County.

Water Management Districts - SUPPORT legislative and administrative action strengthening of partnerships between WMDs and local or regional water utilities to resolve issues with rules and/or policies that have significant impact; and ensure consistent interpretation and application of rules, policies and criteria across WMDs, specifically in the areas of: Consumptive Use Permits; Alternative Water Supply Funding; Water Shortages; Water Conservation; and Water Reservation.

Fire Hydrants - OPPOSE legislation that would preempt local control and any unfunded mandate requiring internal check-valve devices for fire hydrants

State Revolving Loan Funds - SUPPORT continued funding for the State Revolving Fund providing low interest loans for eligible water and waste water system projects.

Aquifer Storage and Recovery - SUPPORT legislative and administrative action to protect the County's existing and future investments in the development of Aquifer Storage and Recovery Facilities from adverse impacts.

Florida Area Coastal Environment (FACE) Initiative - SUPPORT legislative and administrative action in requesting DEP to seek federal funds to support the FACE initiative; and support DEP in its administration of the FACE Program.

Septic Tank Legislation - OPPOSE legislation that would preempt local control and that would place fiduciary burden on the utility to conduct any planning, studies, or reports that are outside of the normal facility expansion requirements.

Administrative Fines - SUPPORT legislation which would provide for greater flexibility by DEP in determining if administrative fines are to be assessed, while giving deference to the general operations of public utilities

DEPARTMENTAL APPROPRIATION REQUESTS

AVIATION

Runway Extension at Tamiami - \$1 million

SUPPORT a \$1 million funding request for the extension of the runway at the Kendall-Tamiami Executive Airport.

Strategic Airport Master Plan - \$2 million

SUPPORT a \$2 million funding request to provide strategic airport master planning for the County's system of five public-use airports (Miami International Airport, Opa-Locka Executive Airport, Homestead General Aviation Airport, Kendall-Tamiami Executive Airport, and Dade-Collier Training and Transition Airport).

Airfield Capacity - \$2.3 million

SUPPORT a \$2.3 million or 50% of the non-federal share funding request to enable MIA to meet airfield capacity requirements for projected activity levels and reduce operating delay costs within the State and the network of national airports.

Foreign Object Debris Detection System - \$2 million

SUPPORT a \$2 million funding request for the installation of an automatic Foreign Object Debris (FOD) detection system to automatically and continuously scan the airfield to detect common runway FOD such as metal objects, glass, plastic, cardboard, birds and wildlife.

Runway 27 Threshold Relocation – \$275,000

SUPPORT a \$275,000 funding request for the relocation of the existing Runway 27 threshold eastward of its existing location to facilitate efficient aircraft movements into and out of the South Terminal Area.

OFFICE OF EMERGENCY MANAGEMENT (OEM)

Emergency Watch Center – \$2 million

SUPPORT a \$2 million funding request for an Emergency Watch Center that will facilitate communication between various public safety agencies (35 cities and the County) and the state warning point on major incidents as they occur.

ENVIRONMENTAL RESOURCES MANAGEMENT (DERM)

Miami River Dredging Federal Advance - \$7.5 million

SUPPORT a \$7.5 million funding request for Miami River Dredging – Federal Channel Advance to complete the dredging project.

C-103 Canal Retrofit - \$850,000

SUPPORT an \$850,000 funding request for the retrofitting existing pipes connecting the roadway drainage to the C-103 Canal to reduce the amount of pollutants carried by urban stormwater discharging to the C-103 Canal, which eventually discharges to Biscayne Bay.

Biscayne Bay Surface Water Quality Monitoring - \$225,000

SUPPORT a \$225,000 funding request for the Biscayne Bay Surface Water Quality Monitoring Program to continue the long-term, quality-assured dataset that is used to support scientifically sound management decisions.

Biscayne Bay Water Quality Model - \$250,000

SUPPORT a \$250,000 funding request for the Biscayne Bay Water Quality Model to help the development of the integrated area-wide land use and water management plan for the south Miami-Dade County watershed as required in the County's adopted CDMP.

HOMELESS TRUST

Jail Diversion Gap Funding - \$270,000

SUPPORT a \$270,000 funding request for a Jail Diversion Gap Funding to replenish a pool of funds to provide immediate access to housing and behavioral health services for individuals with serious mental illnesses being released from jail and awaiting approval of entitlement benefits such as Social Security.

Dually Diagnosed HART - \$479,610

SUPPORT a \$479,610 request for the addition of 18 specialized residential treatment beds for the Homeless Assessment, Referral and Tracking Program (HART) of the Homeless Trust.

HUMAN SERVICES

Elderly High Risk Nutritional Meals - \$871,250

SUPPORT an \$871,250 funding request for meals to seniors at least 60 years of age or older who have been determined to have a nutritional score of 5.5 or higher as determined by the state.

Treatment Alternative for Batterers - \$225,000

SUPPORT a \$225,000 request for two substance abuse treatment counselors plus urinalysis testing as part of alternative treatment for batterers.

INTERNATIONAL TRADE CONSORTIUM

Jay Malina Trade Missions - \$100,000

SUPPORT a \$100,000 funding request for the Jay Malina International Trade Missions to conduct ITC-led business development missions, attract additional business participation on ITC missions, conduct research on trade, and conduct seminars and workshops expanding trade.

PARK AND RECREATION

Trail Glades Range - \$6 million

SUPPORT a \$6 million request for Trail Glades Range for increased shooting and larger range targets for improved marksmanship for state and local law enforcement and area residents.

MetroZoo Amazon and Beyond - \$3.5 million

SUPPORT a \$3.5 million request for Amazon and Beyond at the MetroZoo for the largest exhibit on tropical American flora and fauna in the U.S., and possibly the world, which will focus on biodiversity that is incredibly threatened.

PUBLIC WORKS

Communications Subsystem Conversion Project - \$5 million

SUPPORT a \$5 million funding request for a Communication Subsystem Conversion Project for the Advanced Traffic Management System to replace the traffic signal control system in Miami-Dade County with a new communication subsystem based on a hybrid wireless and fiber-optic technologies.

High Crash Intersection Improvement Study - \$500,000

SUPPORT a \$500,000 funding request for a High Crash Intersection Improvement Study for the top 100 high-crash locations in Miami-Dade County and identify and implement appropriate countermeasures to improve traffic operational safety.

Traffic Signal Control Cabinet Conversion - \$7 million

SUPPORT a \$7 million funding request for a Traffic Signal Control Cabinet Conversion Project to replace the traffic signal control cabinets to improve the flow of traffic on the part of the state highway system that is in Miami-Dade County.

Bike Lane Traffic Study - \$1 million

SUPPORT a \$1 million funding request for a Bike Lane/Facility Implementation Project to conduct traffic studies for arterial streets in Miami-Dade County.

TRANSIT

Orange Line Phase 2 North Corridor Metrorail Extension - \$25 million

SUPPORT a \$25 million funding for the Orange Line Phase 2 North Corridor Metrorail Extension for a 9.5-mile heavy rail project that would run along 27th Avenue.

Orange Line Phase 3 East West MetroRail Extension - \$5 million

SUPPORT a \$5 million funding request for the Orange Line Phase 3 East-West Metrorail Extension for a 10.1 mile heavy rail project that will connect Florida International University to the Miami Intermodal Center (MIC) adjacent to Miami International Airport.

Transit Security System - \$5 million

SUPPORT a \$5 million funding request for a Transit Security System to install security and surveillance systems throughout the County's transit properties and vehicles.

Pedestrian Overpasses on US-1 - \$8 million

SUPPORT an \$8 million funding request for construction of four additional pedestrian overpasses over US-1 at the 27th Avenue, South Miami, University and Dadeland South Metrorail Stations.

SOLID WASTE MANAGEMENT

Beneficial Use of Waste-to-Energy Ash - \$250,000

SUPPORT a \$250,000 funding request for a research project to make beneficial use of ash produced by Miami-Dade County's Waste to Energy plant.

PROPOSED CRITICAL LEGISLATIVE PRIORITIES

Add:

Protect Previous State Funding – SUPPORT efforts to secure the same level of state funding for County programs as last year.

HAVA Funds – SUPPORT the release of funds awarded to the State of Florida for mandated changes to voting equipment through the Help America Vote Act (HAVA).

PROPOSED CRITICAL APPROPRIATION PRIORITIES

Revise:

Miami River Dredging Federal Advance - ~~\$7.5~~ \$10 million

SUPPORT a ~~\$7.5~~ \$10 million funding request for Miami River Dredging – Federal Channel Advance to complete the dredging project.

Delete from Critical Appropriations list, but revise and keep in package:

~~**Emergency Watch Center Information Collection Point – \$2 million**~~

SUPPORT a \$2 million funding request for an Information Collection Point (ICP) that will facilitate communication between various public safety agencies (35 cities and the County) and the state warning point on major incidents as they occur.
