Recommendation of Tourist Development Council Board Appointments

RECOMMENDATION

It is recommended that the Board approve the appointment of the following four (4) nominees to the Tourist Development Council: Mayor Matti Herrera-Bower, Carmen Corvois-Roig, George Cozonis and Olga M. Ramudo.

BACKGROUND

On April 4, 1978, the Board of County Commissioners adopted Ordinance No. 78-28 pursuant to State Statute No. 125.0104, establishing the Tourist Development Council (TDC). The Ordinance and Statute specify that the TDC is a nine (9) member volunteer board that includes: a County Commissioner, who is appointed by the chair of the governing Board of the County; two (2) elected municipal officials, at least one of whom must be from the most populous municipality in the County; three (3) owners or operators of motels, hotels, or other tourist accommodations in the County and subject to the tourist development tax; and three (3) persons involved in the tourist industry and have verifiably demonstrated interest in the tourist development of Miami-Dade County but who are not owners or operators of motels, hotels, or other tourist accommodations in the County and are subject to the tourist development tax.

Further, all members of the Council must be electors of the County and shall serve staggered terms of four years as determined in the appointing resolution. As a result of four (4) anticipated vacancies on the TDC Board due to the expiration of current terms in December 2007, a public nomination process was implemented to fill these positions. These positions require: one (1) elected municipal official; one (1) owner/operator of hotels or other tourist accommodations in the county and subject to the tax; and two (2) individuals that are involved in the tourist industry and have a demonstrated interest in tourist development, but are not owners or operators of motels, hotels, or other tourist accommodations in the County subject to the tourist development tax.

In response to the advertisement for nominations, credentials of eligible candidates for the TDC were submitted and reviewed by the Tourist Development Council Nomination Committee. Present at the meeting were: Commissioner José "Pépe" Diaz, Chairperson, Tourist Development Council; William Talbert, President & CEO, Greater Miami Convention and Visitors Bureau; Stuart Blumberg, President & CEO, Greater Miami & the Beaches Hotel and Motel Association; Dr. Larry Rice, Chairperson, Visitor Industry Council; and Alex Muñoz, Assistant County Manager with responsibility for the TDC. Based on a thorough review of qualifications, the Tourist Development Council Nomination Committee unanimously voted to recommend these candidates to the Board of County Commissioners to fill these vacancies on the TDC Board: Mayor Matti Herrera-Bower, George Cozonis, Carmen Corvois-Roig and Olga M. Ramudo. On November 15, 2007, the Tourist Development Council met and endorsed this recommendation.

Attached are the biographies summarizing the extensive experience of these nominees in the tourism industry and a chart specifically identifying their professional or civic affiliations and their designated terms.

RESOLUTION APPROVING THE APPOINTMENT OF FOUR (4) MEMBERS TO THE TOURIST DEVELOPMENT COUNCIL

WHEREAS, On April 4, 1978, the Board of County Commissioners adopted Ordinance No. 78-28, establishing the Tourist Development Council; and

WHEREAS, the Ordinance directs that each member of the Tourist Development
Council shall be appointed by resolution of the Board of County Commissioners; and

WHEREAS, the Ordinance specifies that the Tourist Development Council shall be composed of 9 members, including a County Commissioner, who is appointed by the chair of the governing Board of the County, two (2) elected municipal officials, three (3) owners or operators of motels, hotels, or other tourist accommodations in the county and subject to the tourist development tax and three (3) persons involved in the tourist industry but who are not owners or operators of motels, hotels or other tourist accommodations in the County subject to the tourist development tax; and

WHEREAS, the Ordinance specifies that all members of the Council must be electors of the County; and

WHEREAS, the Ordinance specifies that Council members shall serve staggered terms of four years as determined in the appointing resolution; and

WHEREAS, the terms of four (4) members of the Tourist Development Council expire in December 2007; and

WHEREAS, the Tourist Development Council board recommends that Mayor Matti Herrera Bower, George Cozonis, Carmen Corvois-Roig, and Olga M. Ramudo be appointed to the Council to fill these positons,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Board approves the appointment of four (4) members to the Tourist Development Council:
