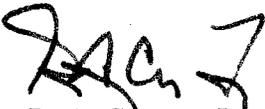

RESOLUTION APPROVING THE WAIVER OF PLAT OF GT GROUP 11740, LLC, D-22837, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 36, TOWNSHIP 54 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 80 STREET, ON THE EAST BY APPROXIMATELY SW 117 AVENUE, ON THE SOUTH BY APPROXIMATELY SW 82 STREET, AND ON THE WEST BY APPROXIMATELY SW 119 AVENUE)

WHEREAS, GT Group 11740, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southeast 1/4 of Section 36, Township 54 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
